



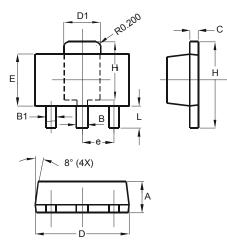
Figure 7. Typical Gain-Bandwidth Product vs. Emitter Current


