




## •Electrical characteristic curves(T<sub>a</sub> = 25°C)




## Fig.1 Grounded emitter propagation

Fig.2 Grounded emitter output characteristics (I)




COLLECTOR TO EMITTER VOLTAGE :  $V_{CE}$  [V]

Fig.3 Grounded emitter output characteristics (II)



Fig.4 DC current gain vs. collector




