



Fig.1 Grounded Emitter Propagation Characteristics





Fig.2 Typical Output Characteristics

Fig.3 DC Current Gain vs. Collector Current (I)





Fig.4 DC Current Gain vs. Collector Current (II)

Fig.5 Collector-Emitter Saturation Voltage vs. Collector Current (I)




Fig.6 Collector-Emitter Saturation
Voltage vs. Collector Current (II)




Fig.7 Base-Emitter Saturation
Voltage vs. Collector Current






Fig.8 Transition Frequency




Fig.10 Safe Operating Erea

COLLECTOR TO EMITTER VOLTAGE :  $V_{CE}\left[V\right]$ 


