



COLLECTOR TO EMITTER VOLTAGE :  $V_{CE}$  [V]


Fig.3 DC Current Gain vs. Collector Current (I)






# Fig.4 DC Current Gain vs. Collector Current (II)





# Fig.7 Base-Emitter Saturation Voltage vs. Collector Current




# Fig.8 Gain Bandwidth Product vs. Emitter Current







# Fig.9 Capacitance vs. Reverse Bias Voltage






# Fig.11 Noise factor vs.collector current characteristics
