## **DESCRIPTION:**


The CBTLV3384 is a ten bit high-speed bus switch with low on-state resistance of the switch allowing connections to be made with minimal propagation delay.

The device is organized as dual 5-bit bus switches with separate outputenable  $(\overline{OE})$  inputs, to allow use as two 5-bit bus switches or one 10-bit bus switch. When  $\overline{OE}$  is low, the associated 5-bit bus switch is on and A port is connected to B port. When  $\overline{OE}$  is high, the switch is open, and a high-impedance state exists between the two ports.


To ensure the high-impedance state during power up or power down,  $\overline{\text{OE}}$  should be tied to Vcc through a pullup resistor; the minimum value of the resistor is determined by the current-sinking capability of the driver.


## SIMPLIFIED SCHEMATIC, EACH SWITCH


