



FIG.1: Maximum average power dissipation (Single phase half wave)




FIG.3: Gate temperature

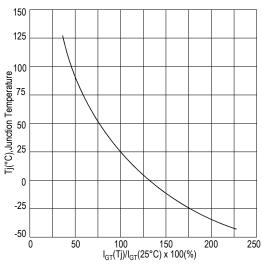





FIG.5: On-state characteristics(Max)











