



FIG.1: Maximum average power dissipation (Single phase half wave)





FIG.3: Gate trigger current VS Junction temperature






FIG.2: Average on-state current VS Allowable case Temperature(Single phase half wave)





FIG.4: Rated surge on-state current (Non-Repetitive)






