






FIG.2: Maximum on-state power dissipation




FIG.4: Maximum transient thermal impedance





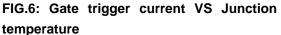



FIG.3: Typical RMS on-state current VS Allowable case Temperature














