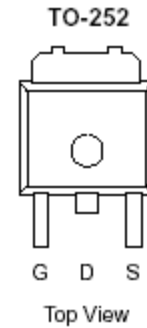
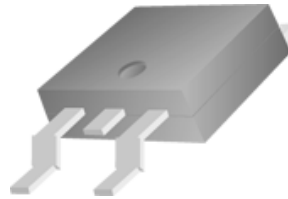


P-Channel 20-V (D-S) MOSFET
