





Qg - Total Gate Charge (nC)



I<sub>D</sub> - Drain Current (A)






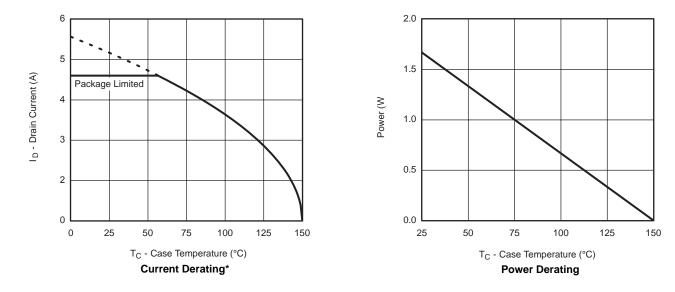
