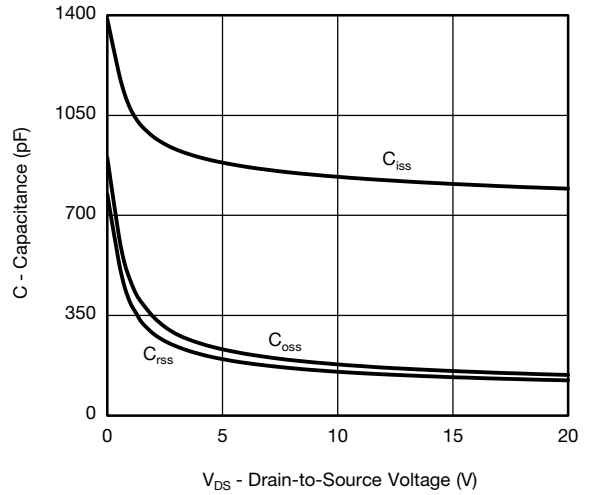

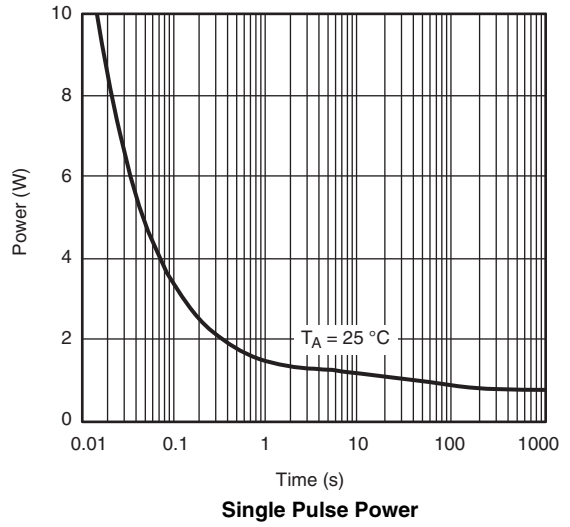
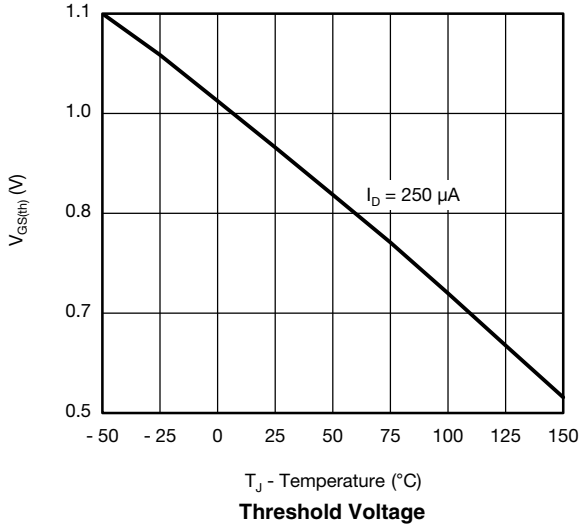
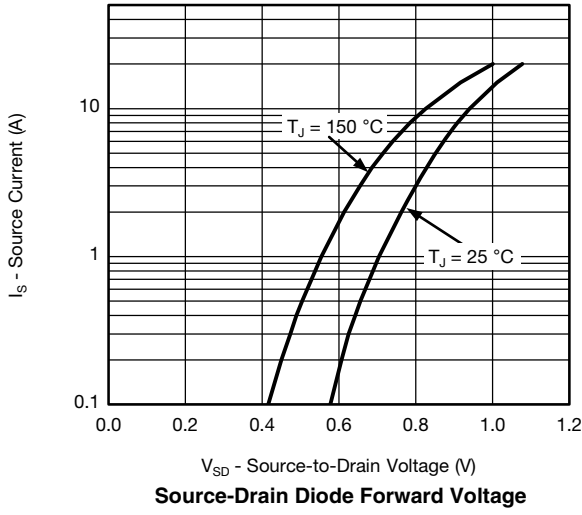


**Gate Charge**
