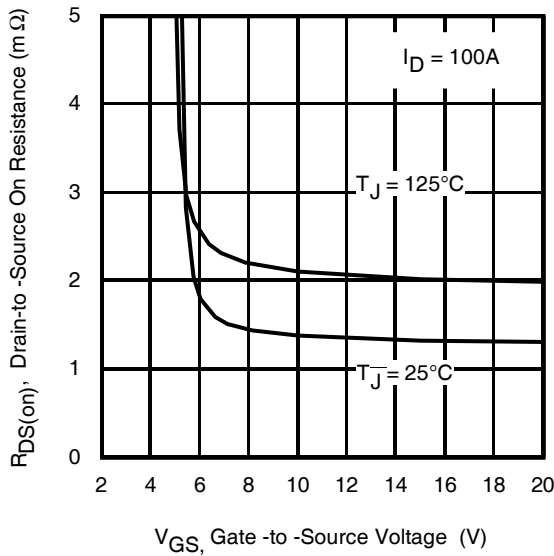
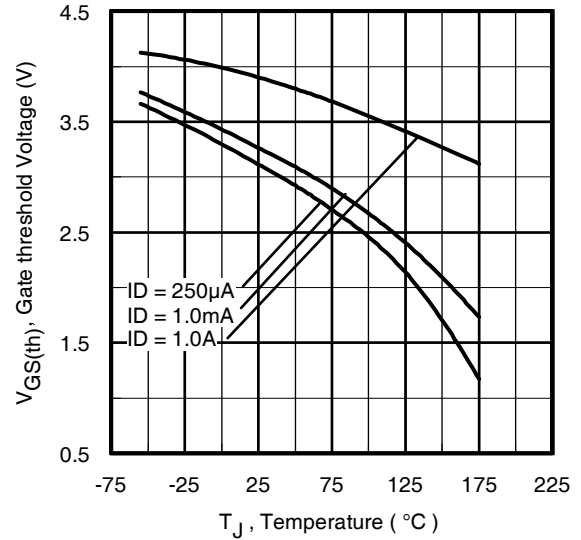

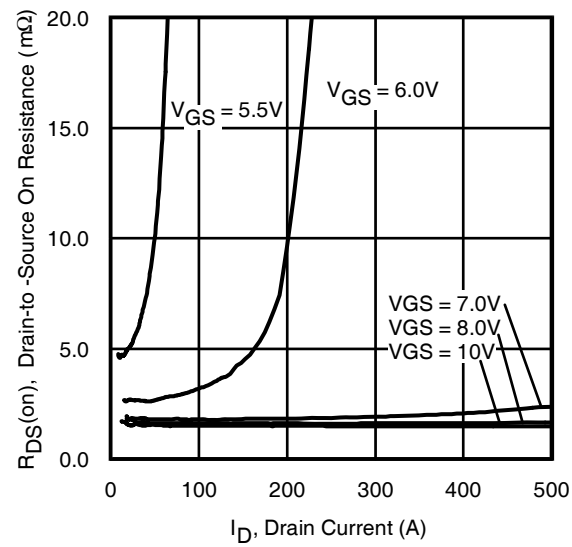


Fig 22. Typical On-Resistance vs. Drain Current

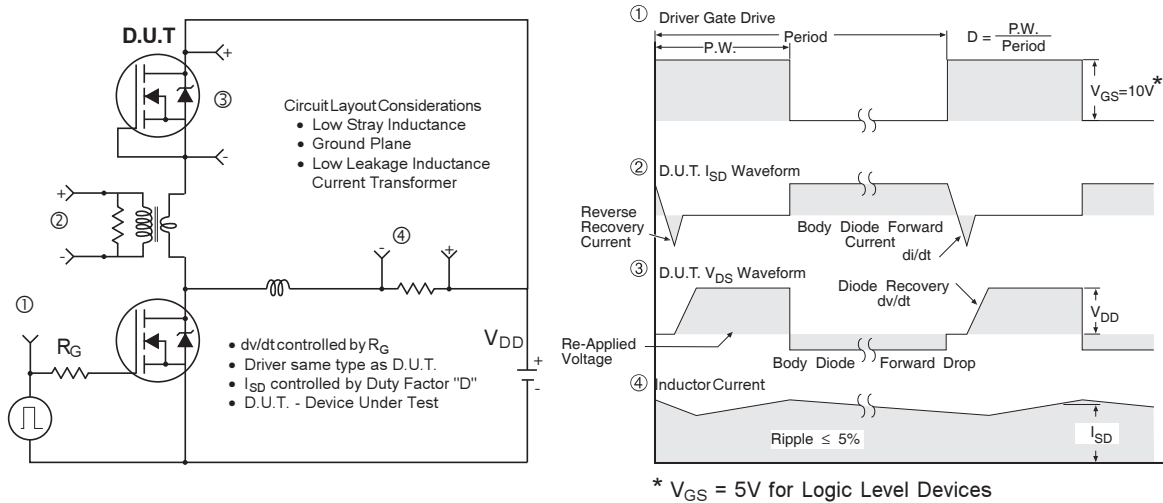
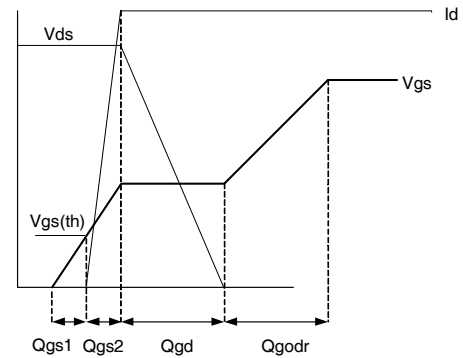
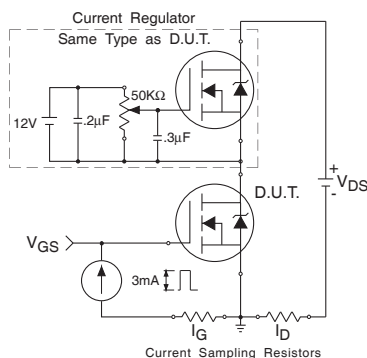
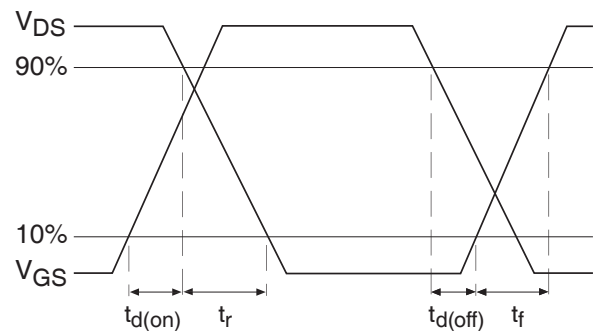
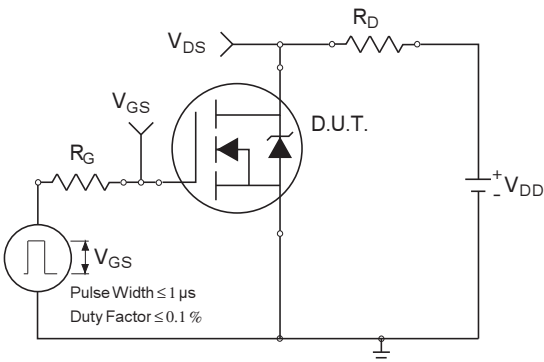
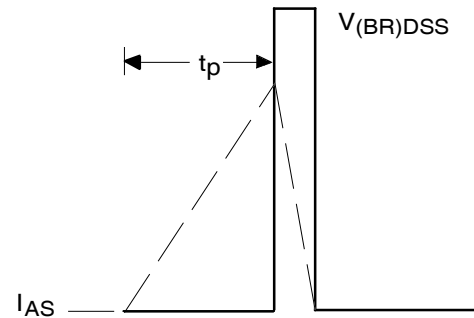
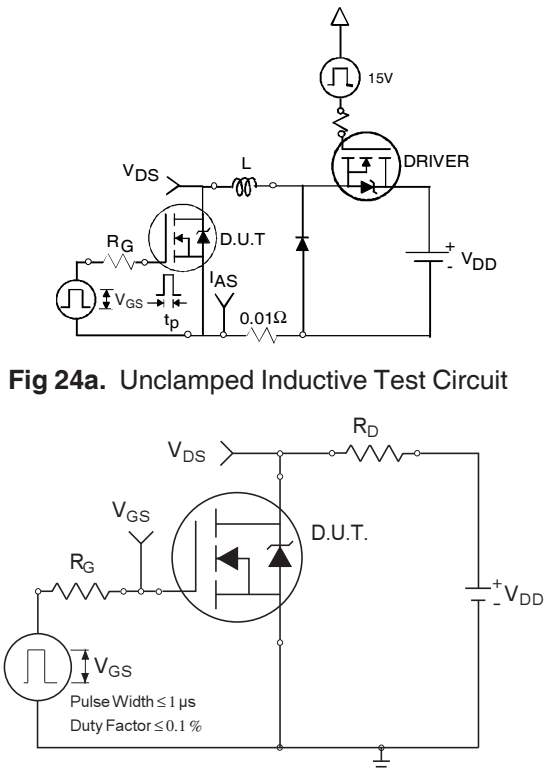
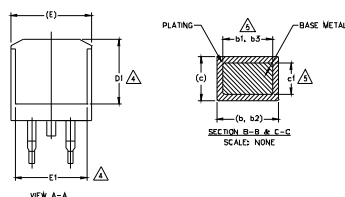
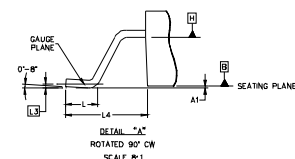
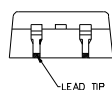
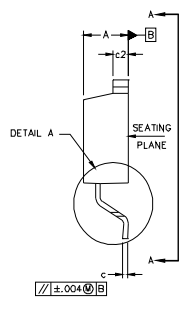
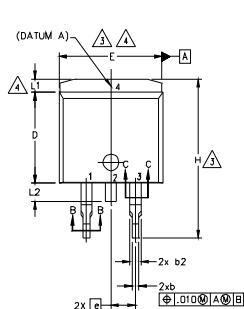


Fig 23. Peak Diode Recovery dv/dt Test Circuit for N-Channel HEXFET® Power MOSFETs
