




Fig. 1 Forward Resistance vs. Forward Current




Fig. 3 Forward Current vs. Forward Voltage




Fig. 2 Diode Capacitance vs. Reverse Voltage




Fig. 4 Reverse Voltage vs. Reverse Current






Fig. 5 Typical Charge Recovery Curve
