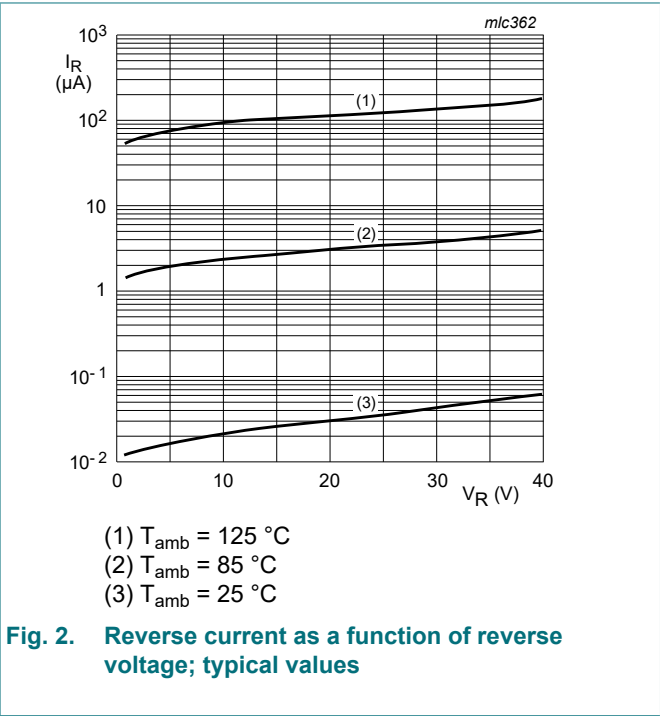

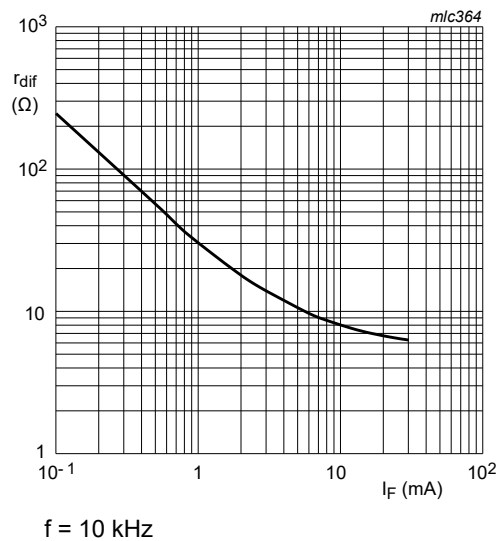


Fig. 3. Differential resistance as a function of forward current; typical values

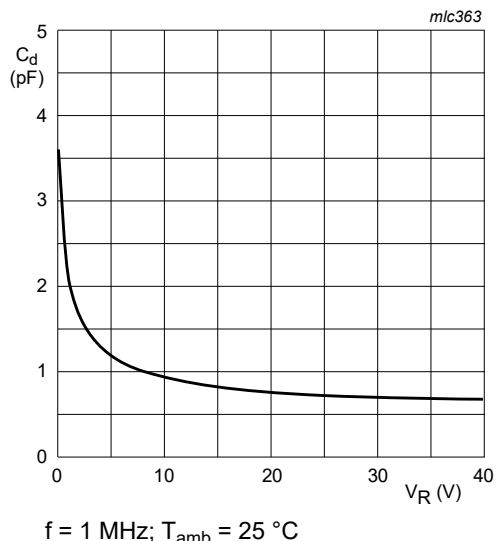


Fig. 4. Diode capacitance as a function of reverse voltage; typical values

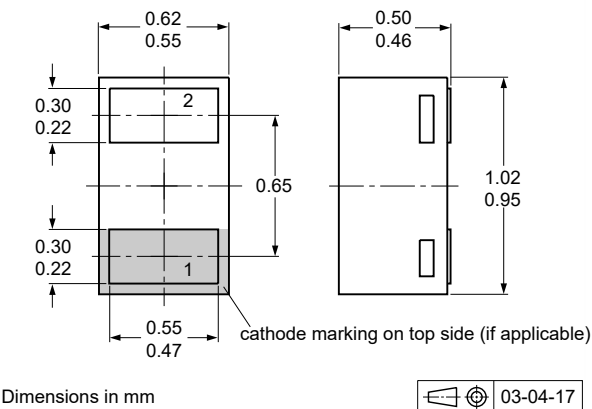


Fig. 5. Package outline DFN1006-2 (SOD882)

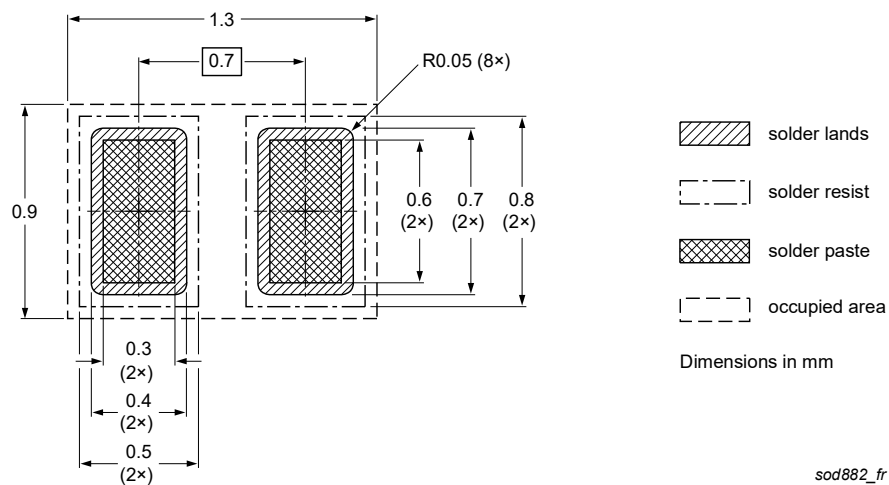


Fig. 6. Reflow soldering footprint for DFN1006-2 (SOD882)
