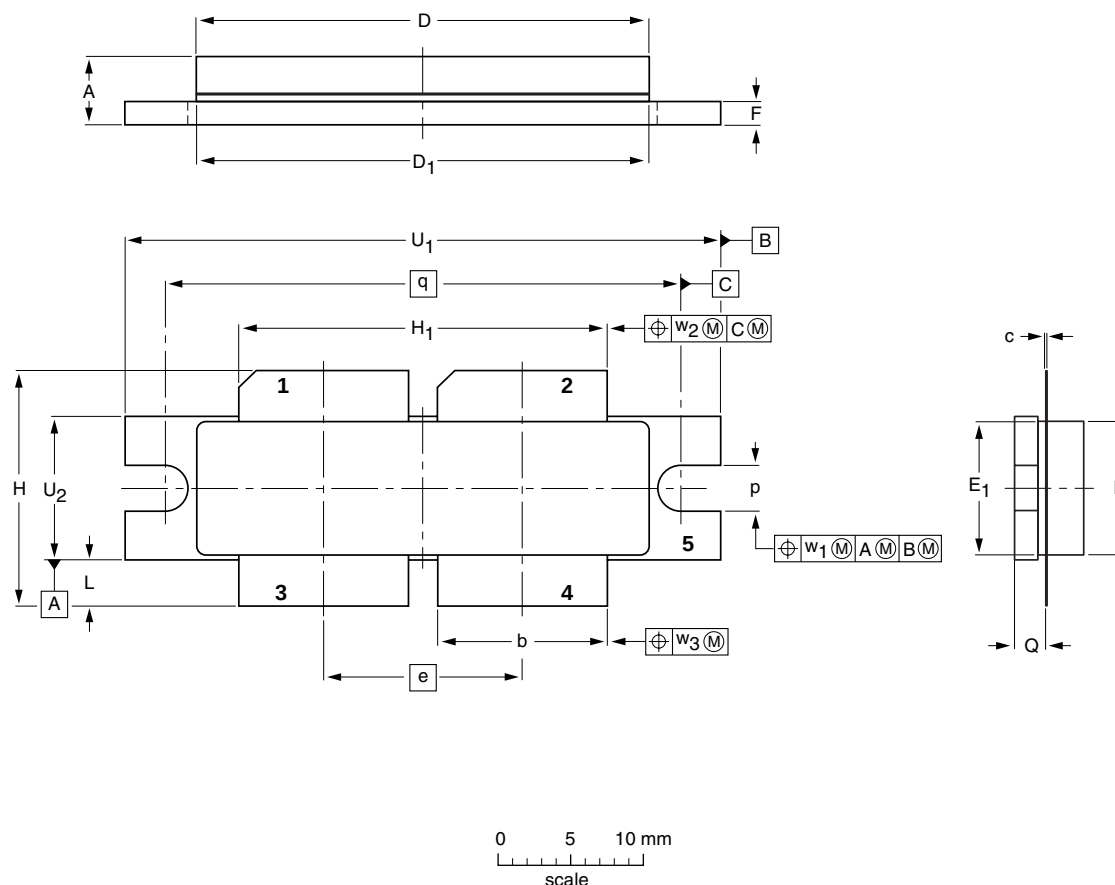
7.1 Ruggedness in class-AB operation

The BLF7G22L-250P and BLF7G22LS-250P are capable of withstanding a load mismatch corresponding to VSWR = 10 : 1 through all phases under the following conditions: $V_{DS} = 32\text{ V}$; $I_{Dq} = 2160\text{ mA}$; $P_L = 70\text{ W}$ (CW); $f = 2140\text{ MHz}$.

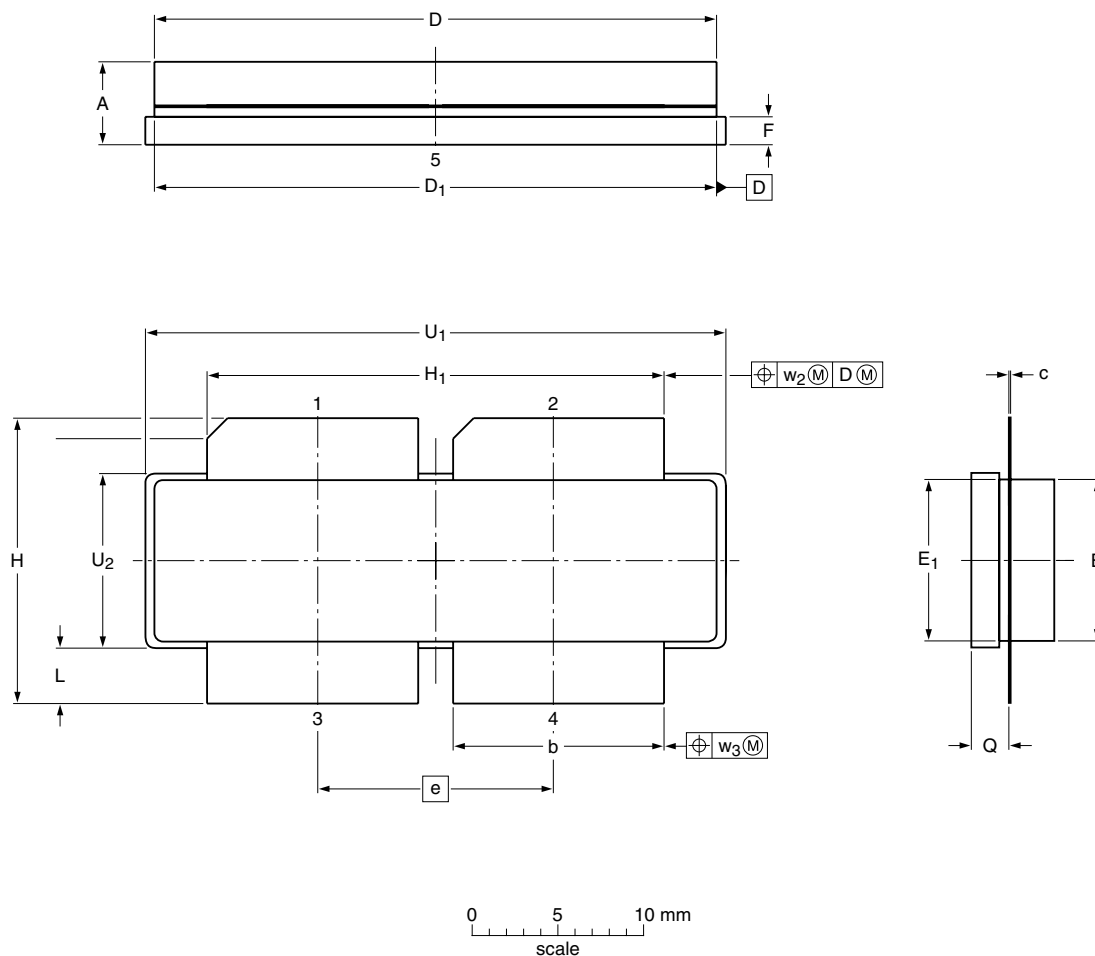
