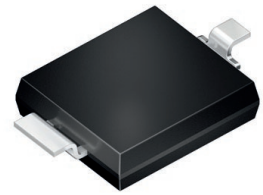

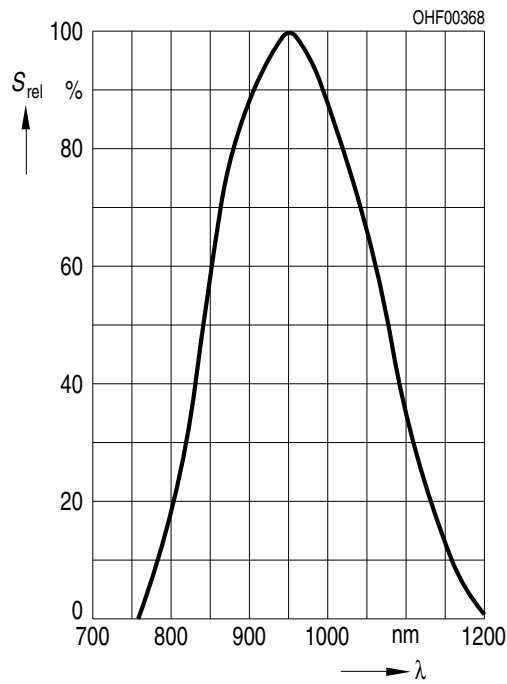

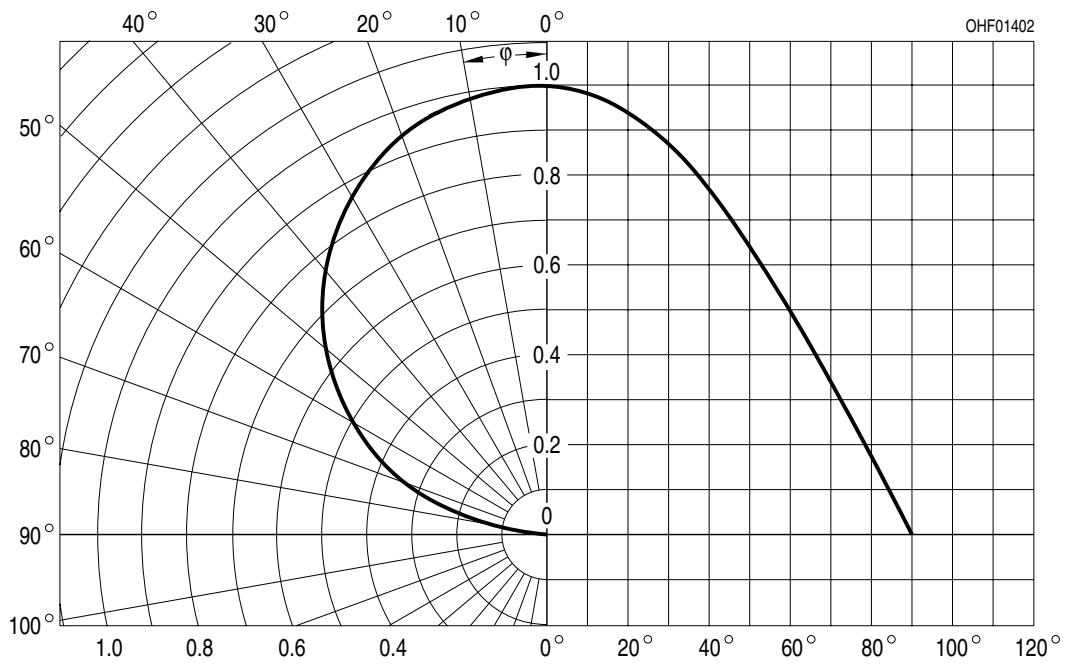
## Relative Spectral Sensitivity <sup>1), 2)</sup>

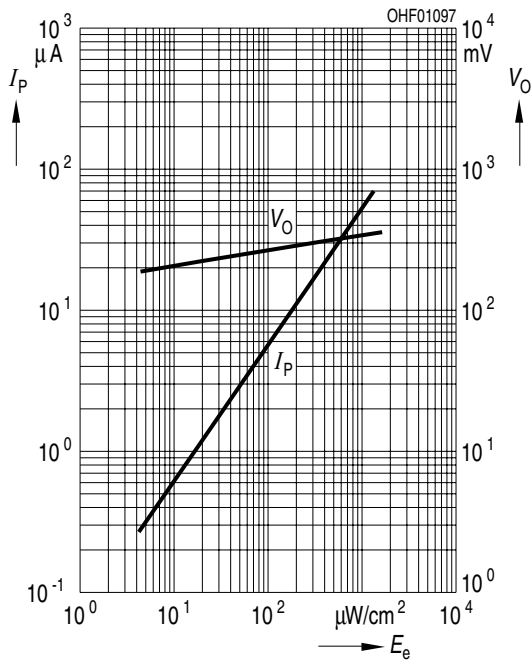
## Directional Characteristics <sup>1), 2)</sup>

$$S_{rel} = f(\varphi)$$



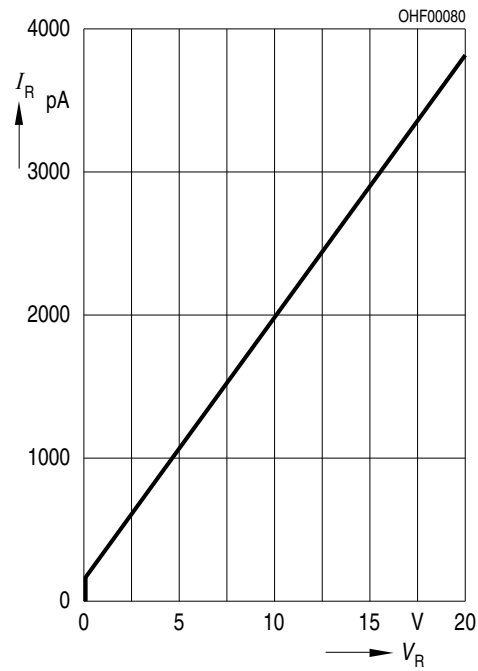

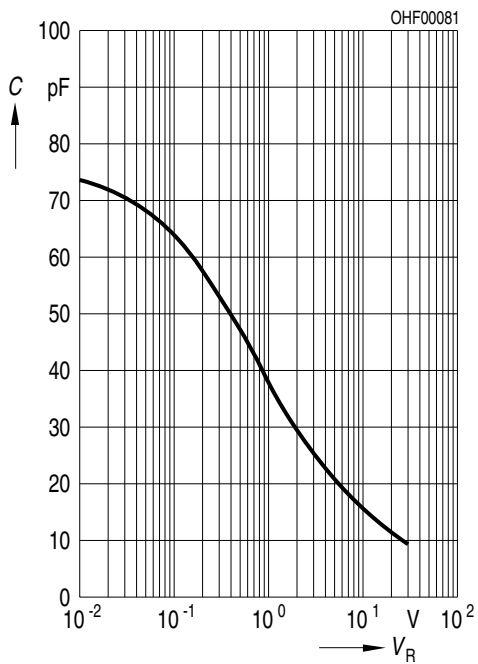

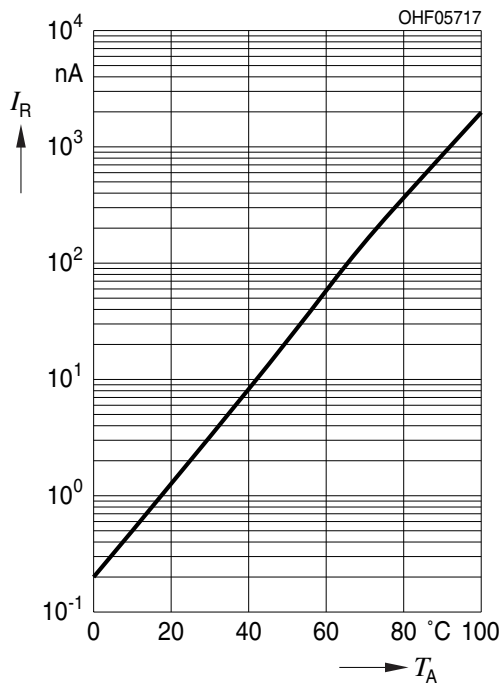

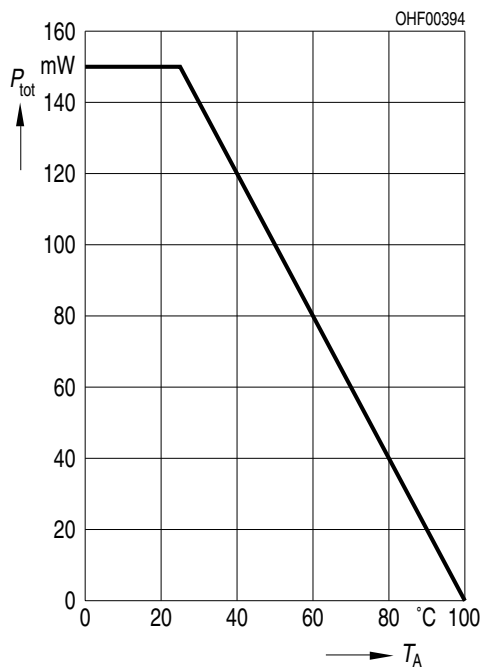
### Dark Current <sup>2)</sup>

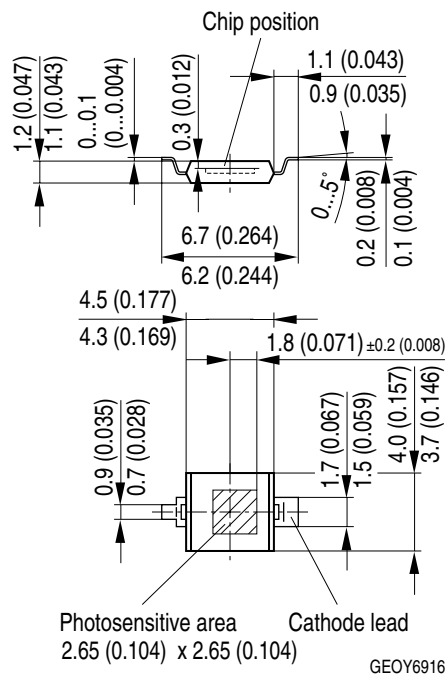


### Power Consumption

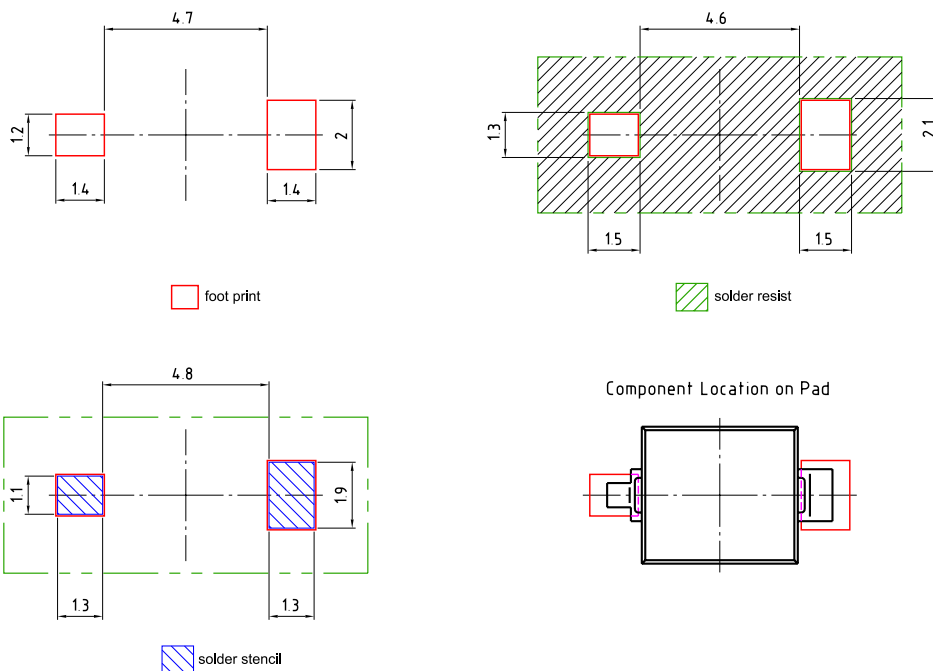
Dimensional Drawing <sup>3)</sup>

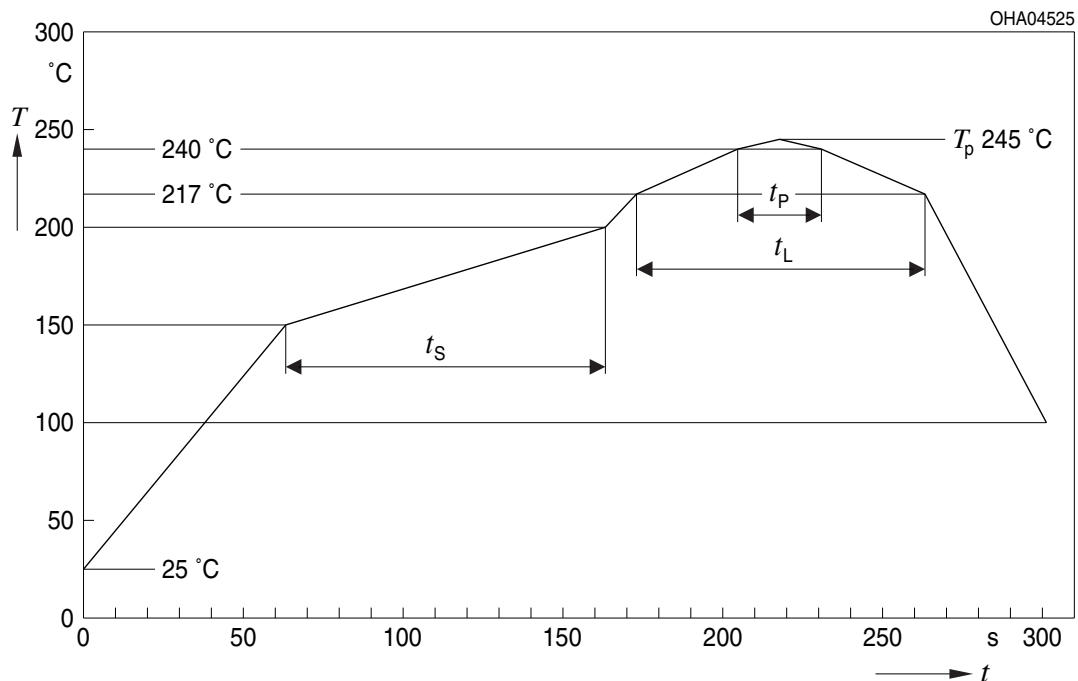
### Recommended Solder Pad <sup>3)</sup>

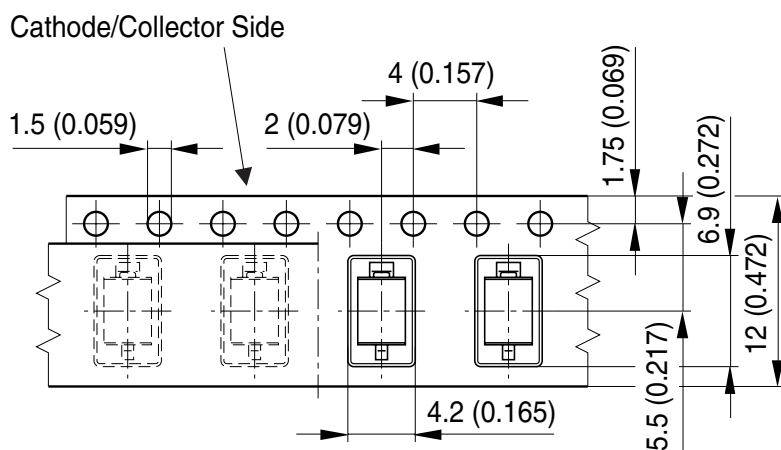

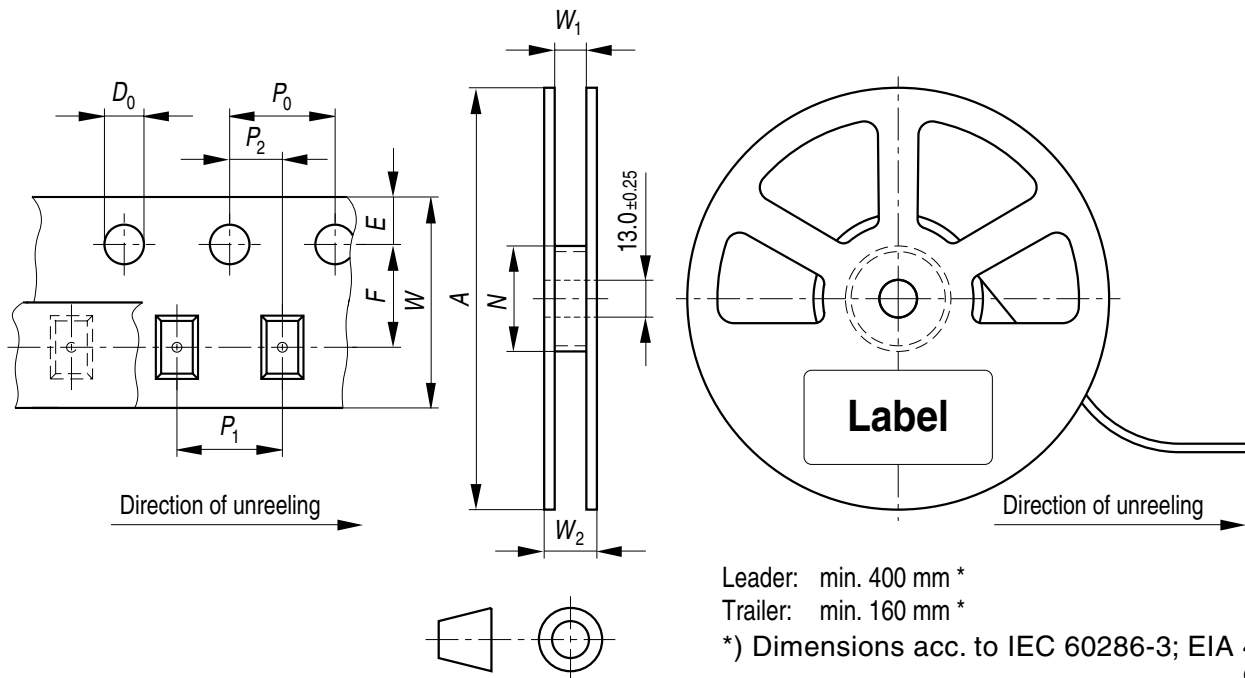

**Tape and Reel** <sup>4)</sup>



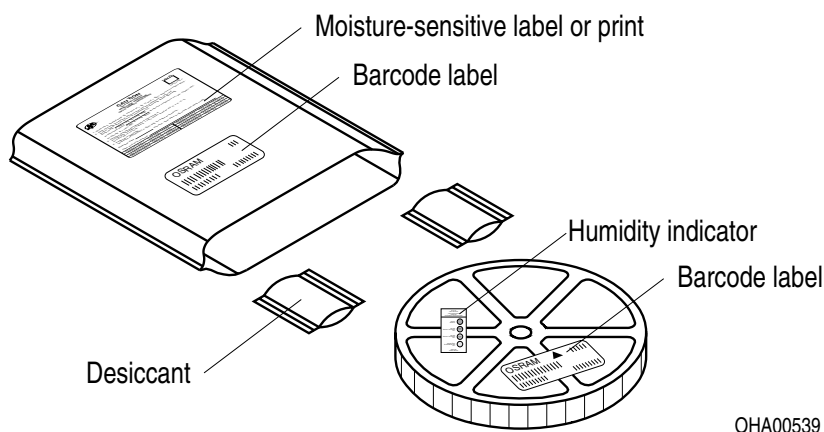

## Notes
