

1. General description

Planar passivated high commutation three quadrant triac in a SOT404 plastic package intended for use in circuits where high static and dynamic dV/dt and high dl/dt can occur. This "series B" triac will commutate the full RMS current at the maximum rated junction temperature without the aid of a snubber.






Fig. 2. RMS on-state current as a function of mounting base temperature; maximum values






Fig. 7. Normalized gate trigger current as a function of junction temperature






Fig. 9. Normalized holding current as a function of junction temperature










