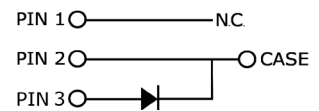
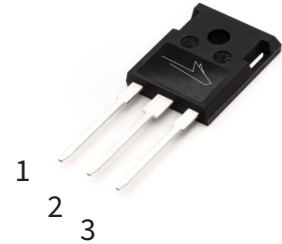

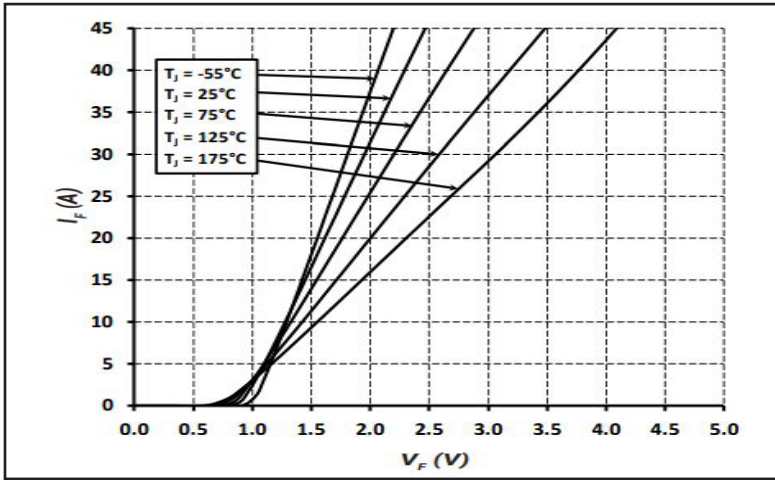

Forward Characteristics

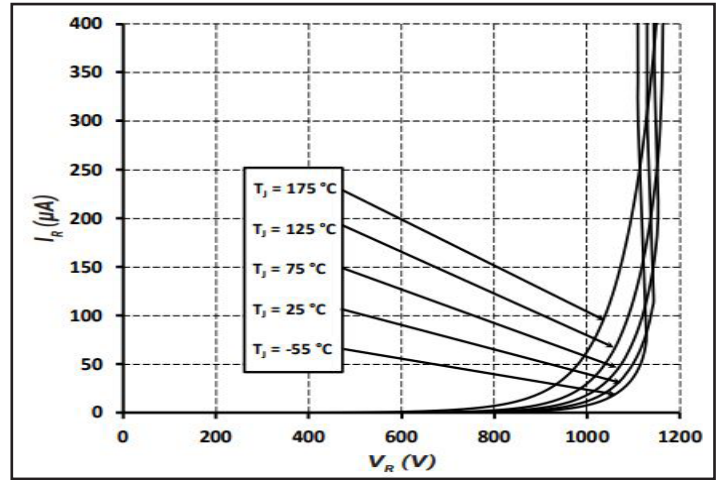

Reverse Characteristics

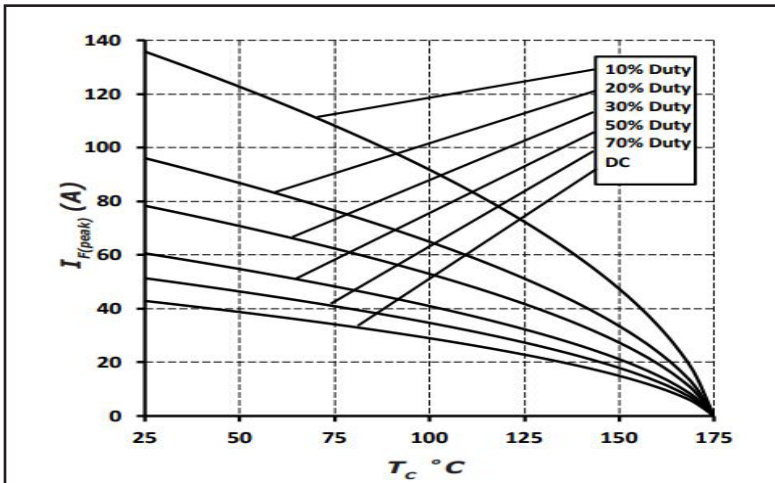

Current Derating

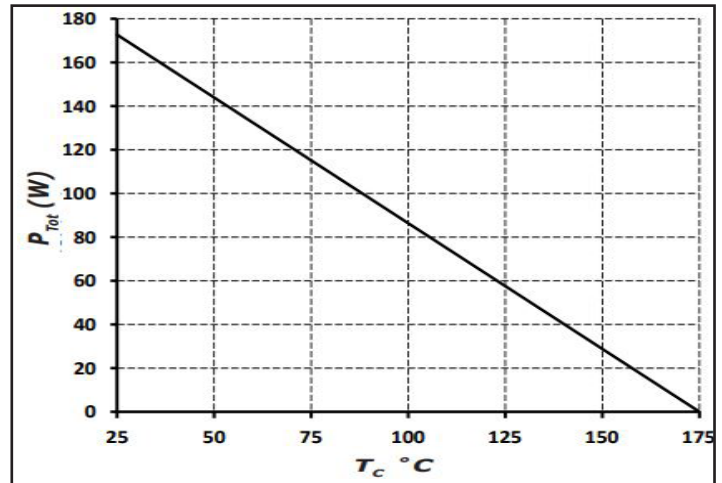

Power Derating

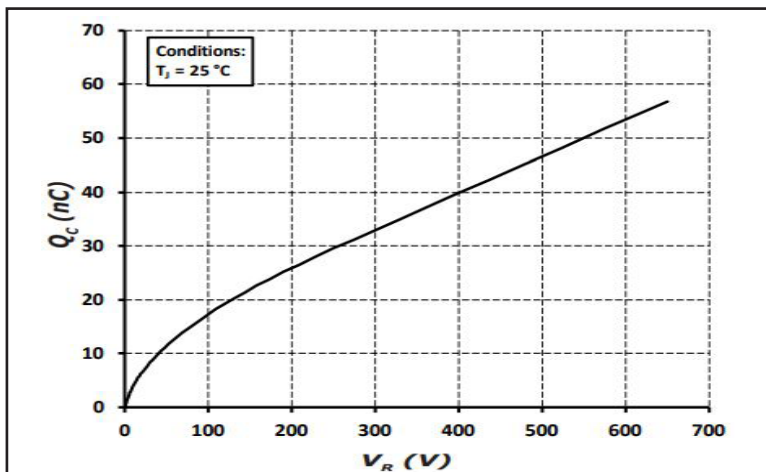

Total Capacitance Charge vs. Reverse Voltage

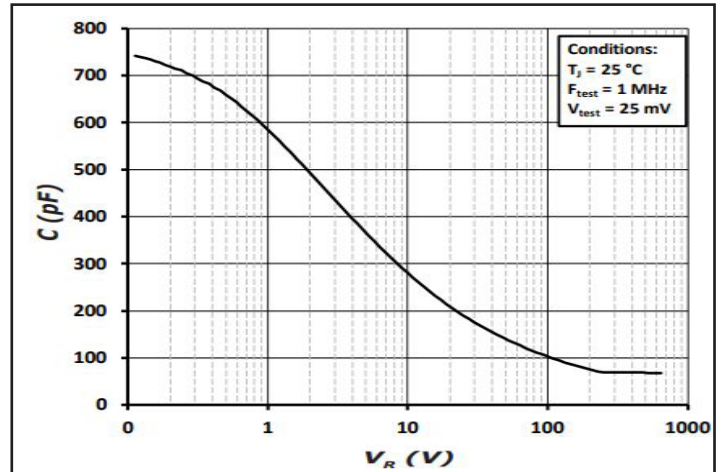

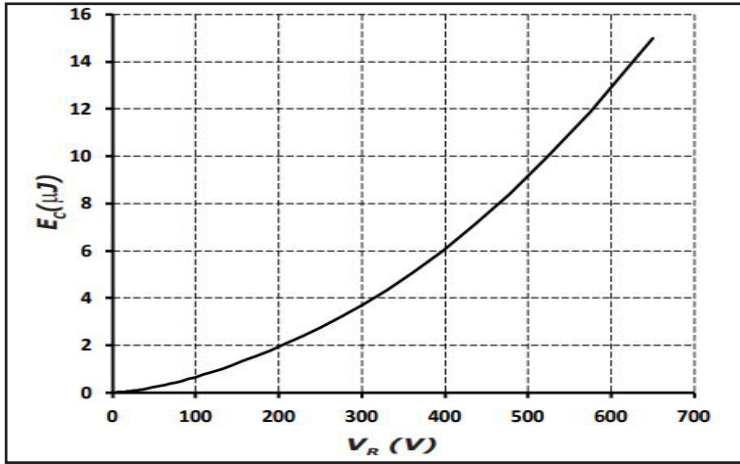

Capacitance Stored Energy

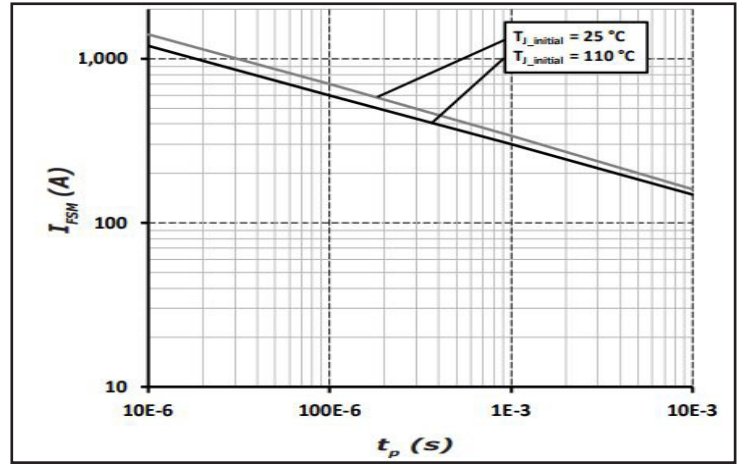

Non-Repetitive Peak Forward Surge Current vs. Pulse Duration

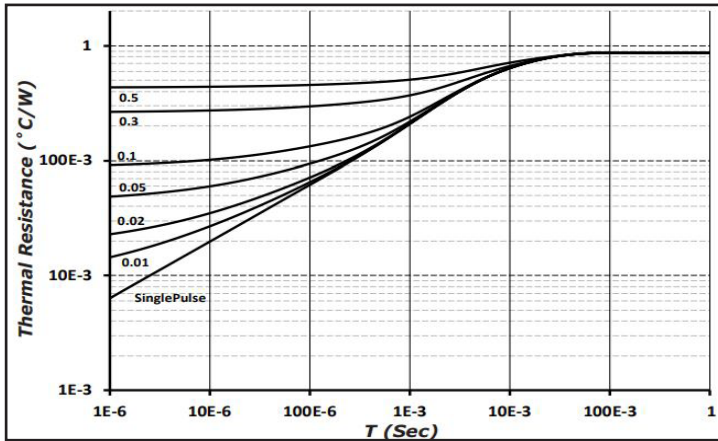
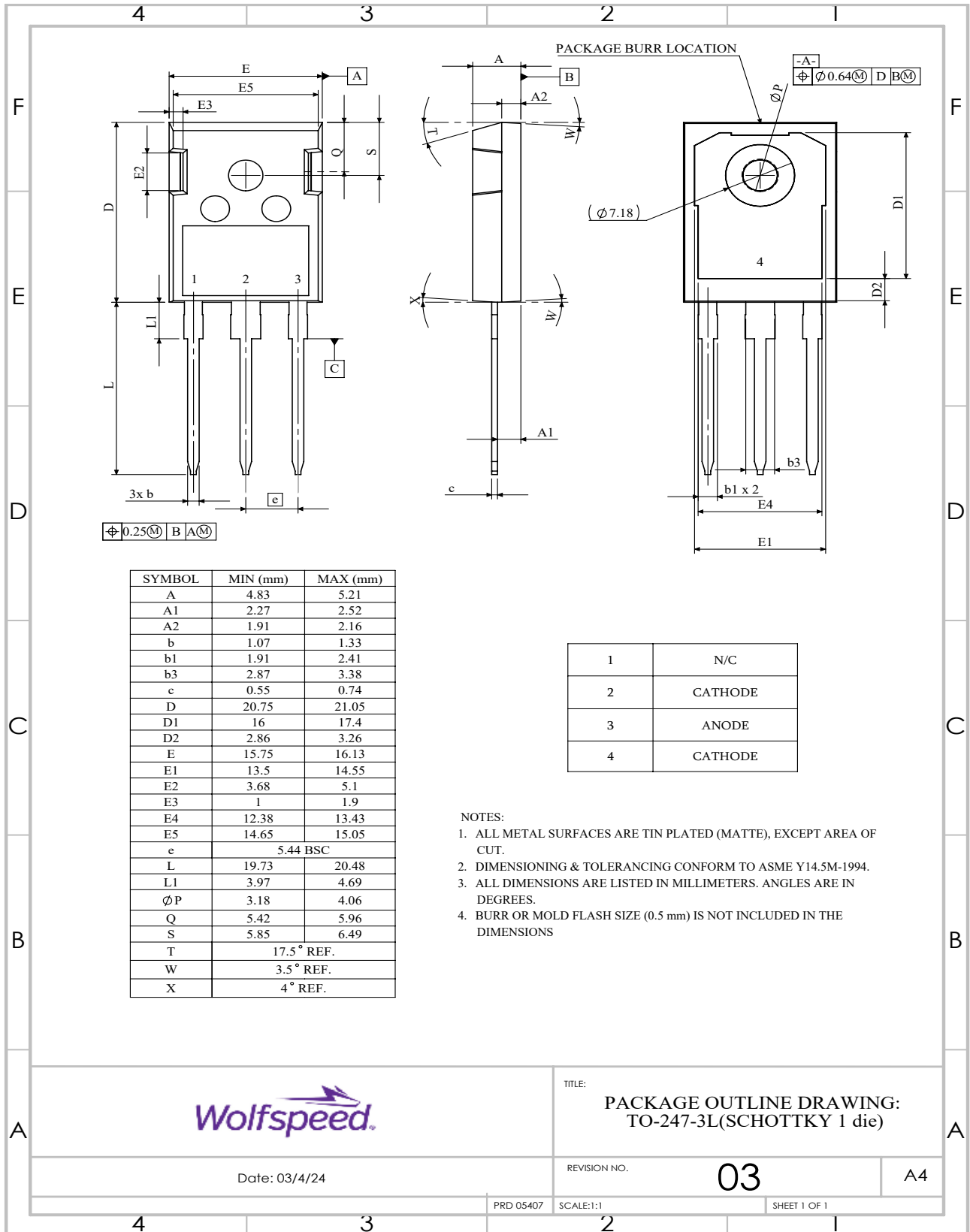

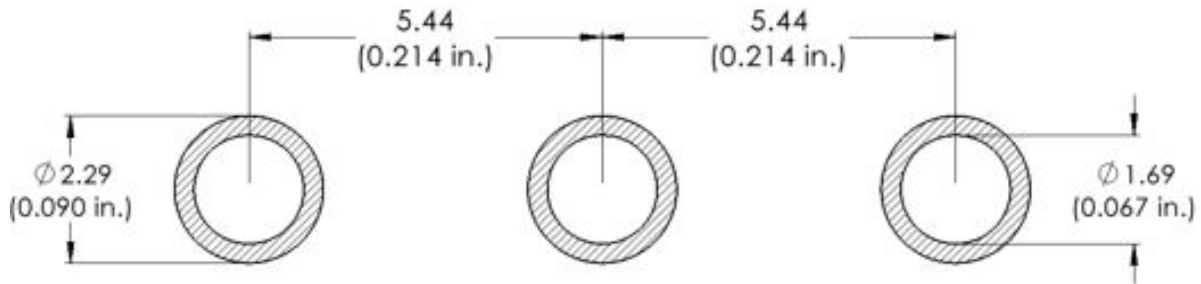

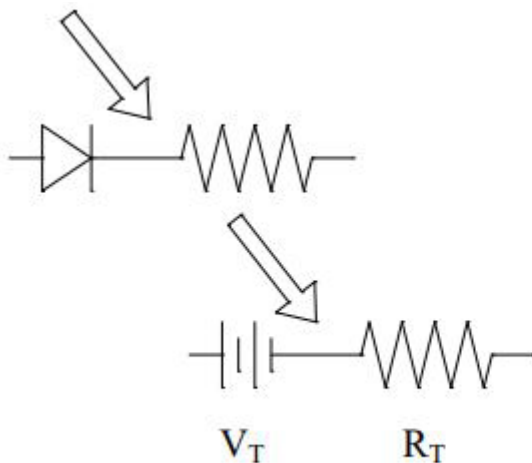
