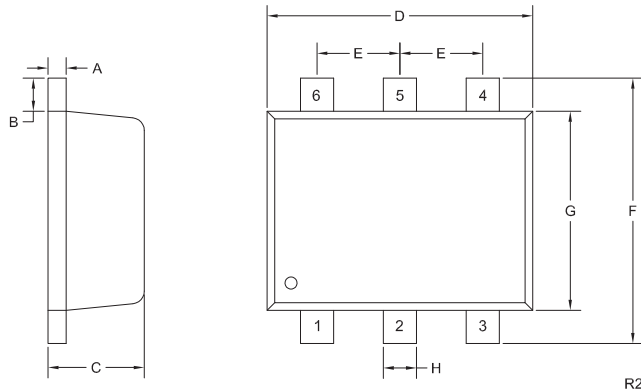

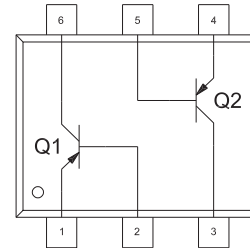
SOT-563 CASE - MECHANICAL OUTLINE

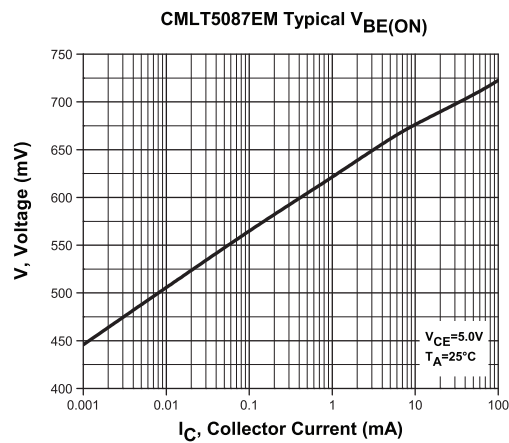
PIN CONFIGURATION
