Typical MOSFET Characteristics (continued)



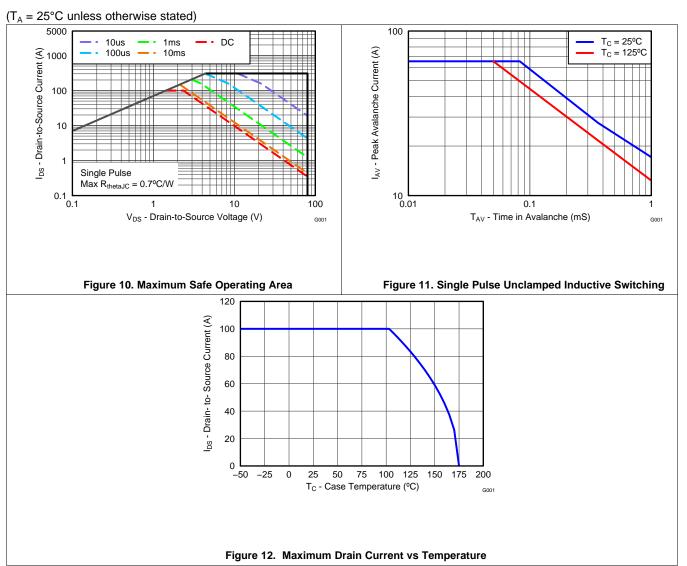

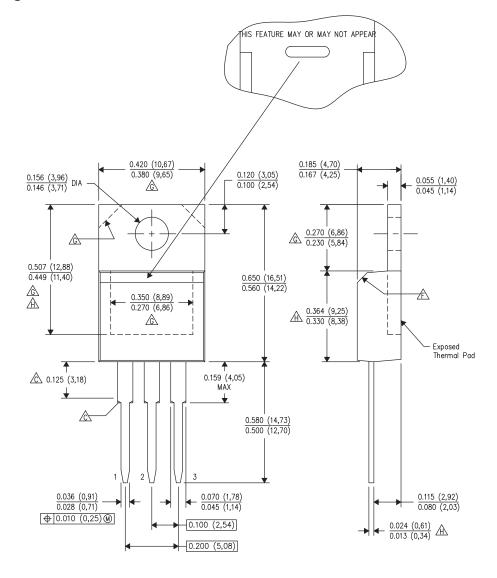
