




























Fig. 9 Typical Drain-Source Leakage Current vs. Voltage






Fig. 11 Gate Charge Characteristics











Fig. 18 On-Resistance Variation with Temperature




Fig. 20 Diode Forward Voltage vs. Current






Fig. 21 Typical Drain-Source Leakage Current vs. Voltage







Fig. 23 Gate Charge Characteristics






