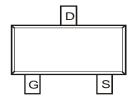

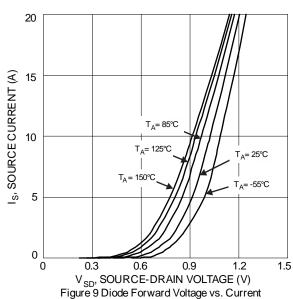


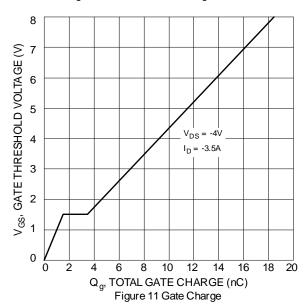












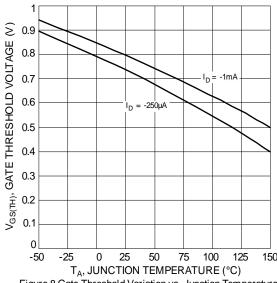
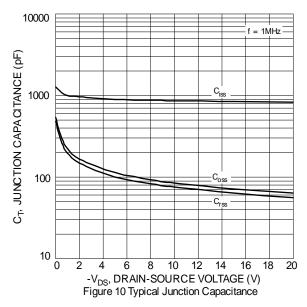
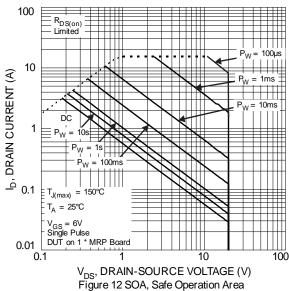


Figure 8 Gate Threshold Variation vs. Junction Temperature







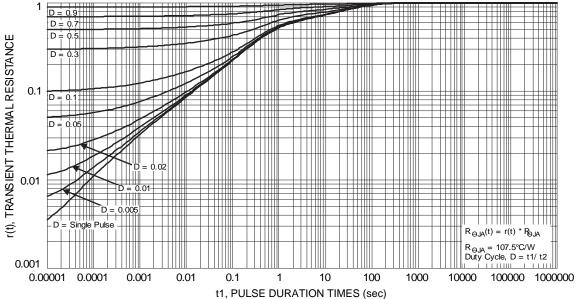


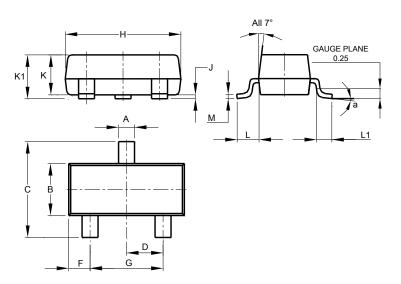
Figure 13. Transient Thermal Resistance

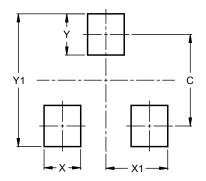
