









Drain to Source Voltage Output Characteristics




Gate to Source Voltage
Drain to Source Resistance vs. Gate to Source Voltage




Source to Drain Voltage Body Diode Forward Characteristics



Gate to Source Voltage Transfer Characteristics





Drain to Source Resistance vs. Drain Current













Source to Drain Voltage Safe Operating Area, Junction-to-Ambient
