






**On-Resistance vs. Junction Temperature** 




On-Resistance vs. Gate-to-Source Voltage




Source-Drain Diode Forward Voltage




Normalized Thermal Transient Impedance, Junction-to-Foot

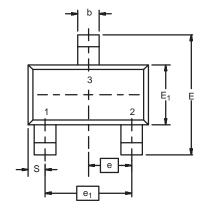


