









Source-Drain Diode Forward Voltage




V_{DS} - Drain-to-Source Voltage (V) Capacitance




On-Resistance vs. Junction Temperature




Threshold Voltage




Drain Source Breakdown vs. Junction Temperature



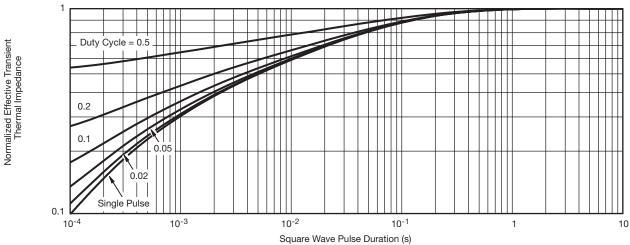

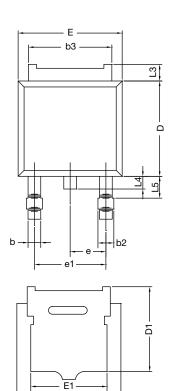


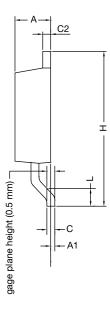
Normalized Thermal Transient Impedance, Junction-to-Case


