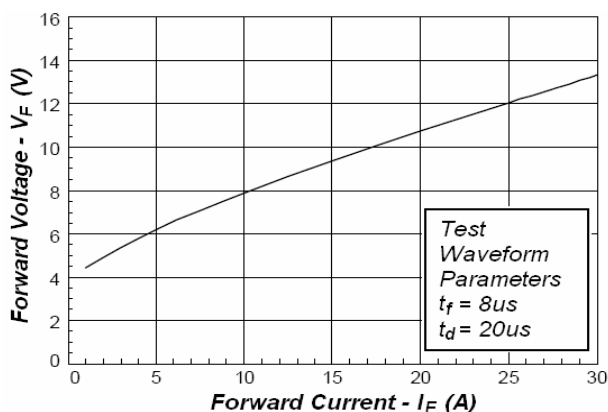
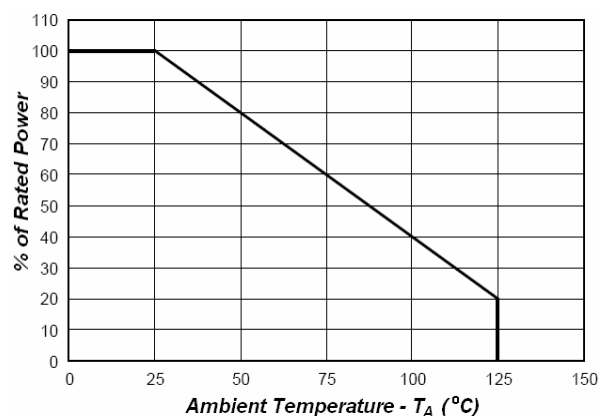
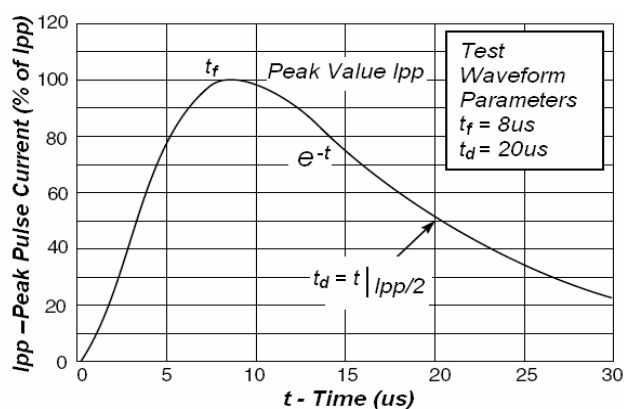
Pin Configuration
