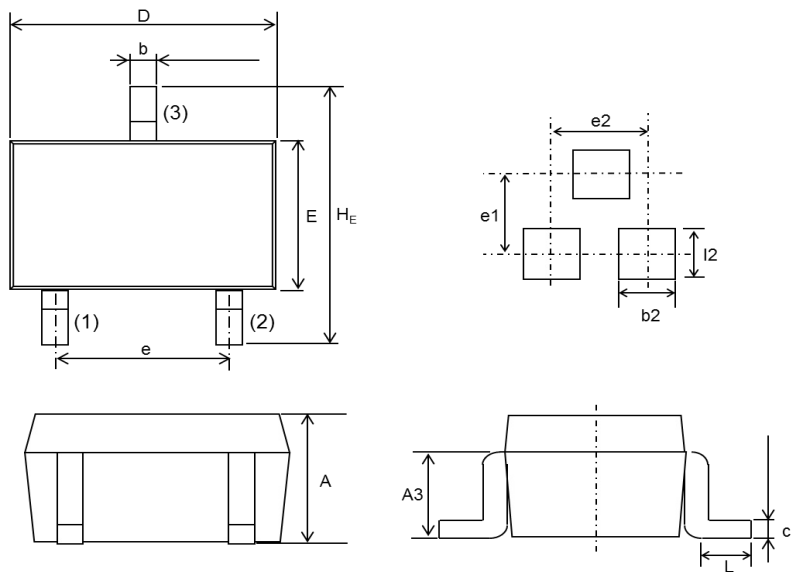

● Characteristic Curves

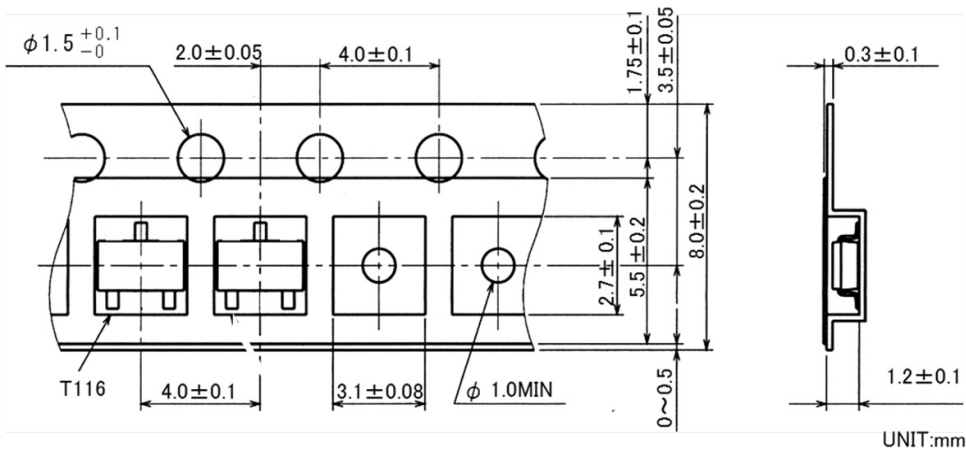
