






Figure 3. Typical Saturation Voltage Characteristics




Figure 5. Saturation Voltage vs. Case
Temperature at Variant Current Level




Figure 2. Typical Output Characteristics




Figure 4. Transfer Characteristics




Figure 6. Saturation Voltage vs. V_{GE}




Figure 7. Saturation Voltage vs. V_{GE}




Figure 9. Capacitance Characteristics




Figure 11. SOA Characteristics




Figure 8. Saturation Voltage vs. V_{GE}




Figure 10. Gate charge Characteristics




Figure 12. Load Current vs. Frequency




Figure 13. Turn-on Characteristics vs.
Gate Resistance




Figure 15. Turn-on Characteristics vs. Collector Current




Figure 17. Switching Loss vs. Gate Resistance




Figure 14. Turn-off Characteristics vs.
Gate Resistance




Figure 16. Turn-off Characteristics vs.
Collector Current




Fig 18. Switching Loss vs. Collector Current




Figure 19. Turn off Switching SOA Characterisics




Figure 21. Reverse Current




Figure 23. Reverse Recovery Characteristics vs. Forward Current




Figure 20. Forward Characteristics




Figure 22. Reverse Recovery Characteristics vs. di_F/dt





Figure 24.Transient Thermal Impedance of IGBT






Figure 25. TO-3P 3L - 3LD, T03, PLASTIC, EIAJ SC-65
