

FIG. 1- DERATING CURVE OUTPUT RECTIFIED




FIG. 3- TYPICAL FORWARD VOLTAGE




FIG. 2- -MAXIMUM NON-REPETITIVE PEAK FORWARD **SURGE CURRENT PERLEG**






FIG. 4- TYPICAL REVERSE LEAKAGE




