1. General description

The HEF4071B is a quad 2-input OR gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{DD} .

2. Features and benefits

- Fully static operation
- 5 V, 10 V, and 15 V parametric ratings
- CMOS low power dissipation
- High noise immunity
- Standardized symmetrical output characteristics
- Inputs and outputs are protected against electrostatic effects

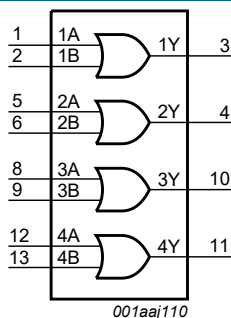


Fig. 1. Functional diagram

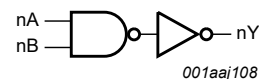
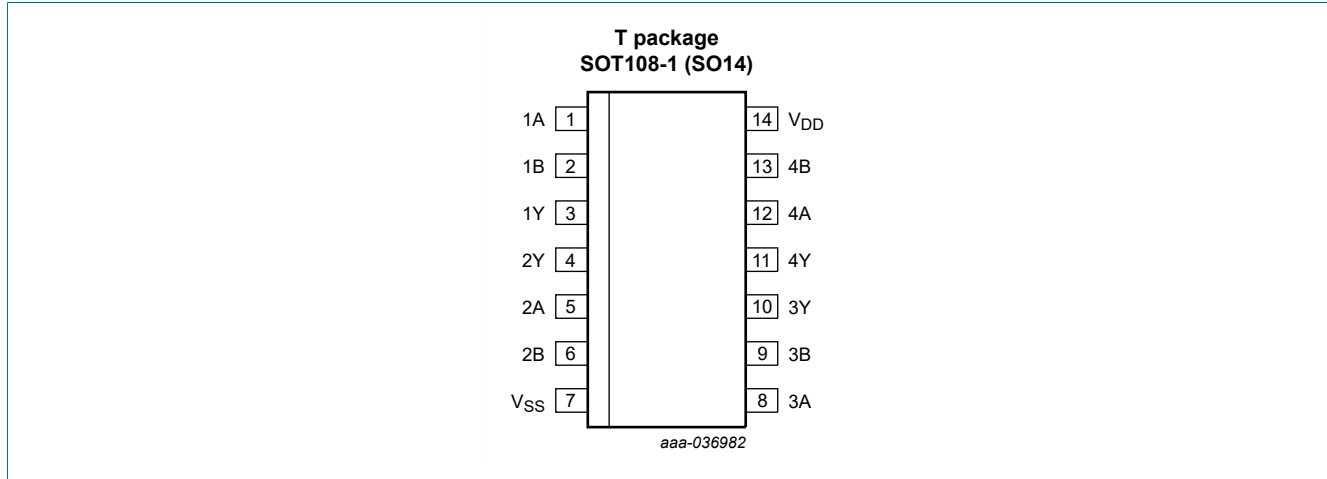


Fig. 2. Logic diagram (one gate)

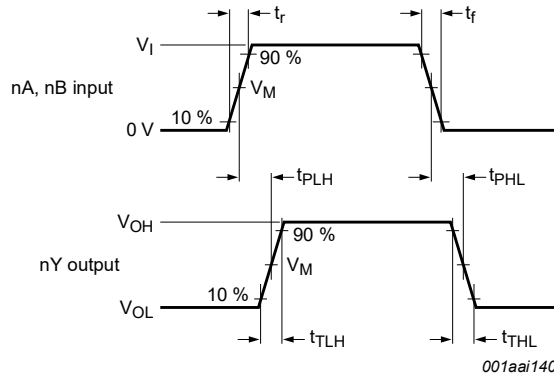

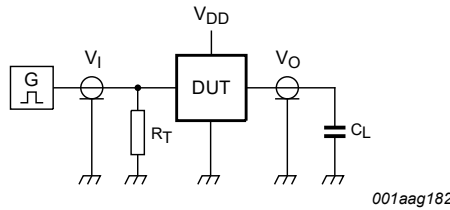

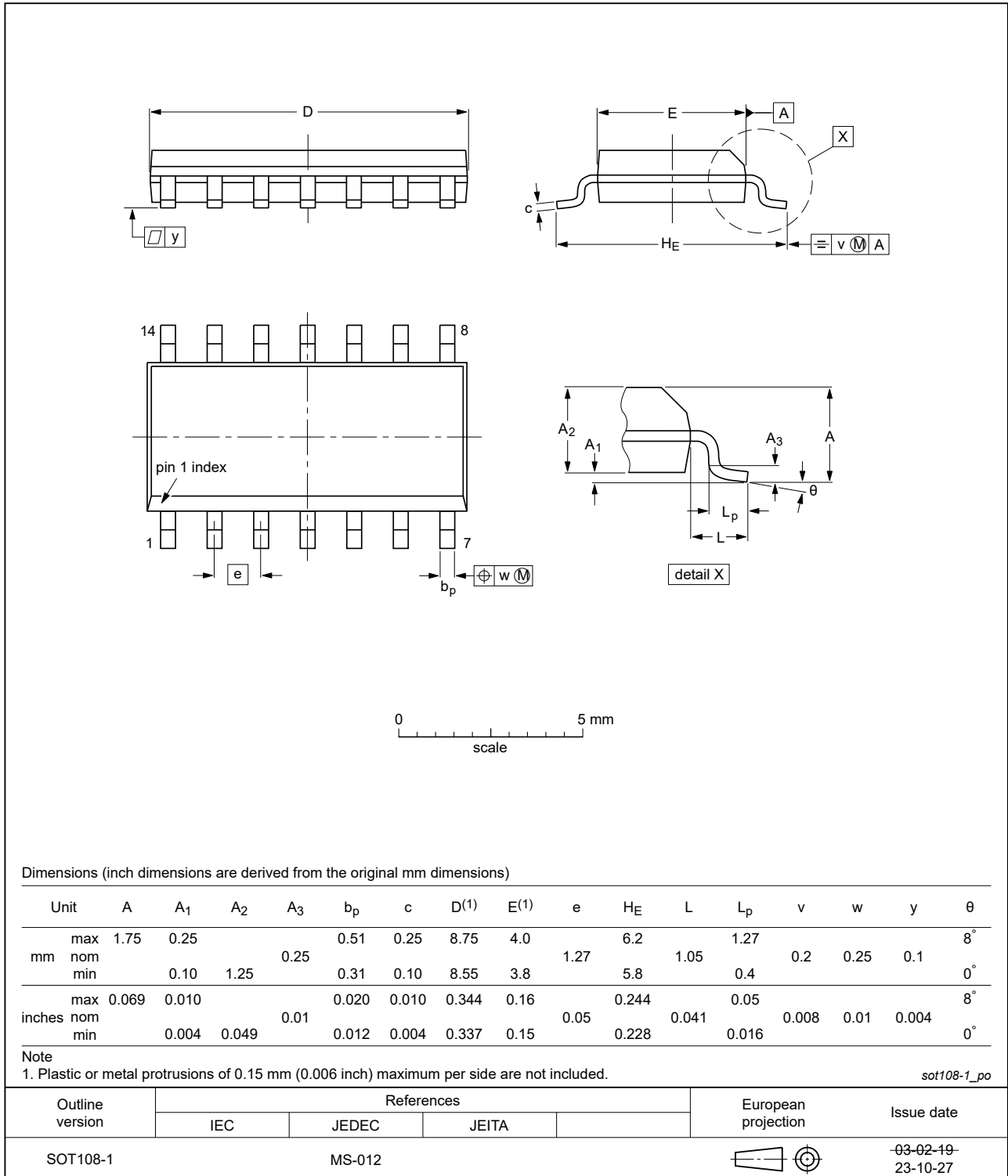


Fig. 5. Package outline SOT108-1 (SO14)
