Description

The ILD32/ ILQ32 are optically coupled isolators with a gallium arsenide infrared LED and a silicon photo-darlington sensor. Switching can be achieved while maintaining a high degree of isolation between driving and load circuits.

These optocouplers can be used to replace reed and mercury relays with advantages of long life, high speed switching and elimination of magnetic fields.




Figure 1. Forward Voltage vs. Forward Current






Figure 2. Normalized Non-saturated and Saturated CTR_CE vs. **LED Current**





Figure 6. Switching Timing






Figure 4. Low to High Propagation Delay vs. Collector Load Resistance and LED Current

Figure 7. Switching Schematic






Figure 5. High to low Propagation Delay vs. Collector Load Resistance and LED Current



Package Dimensions in Inches (mm)


