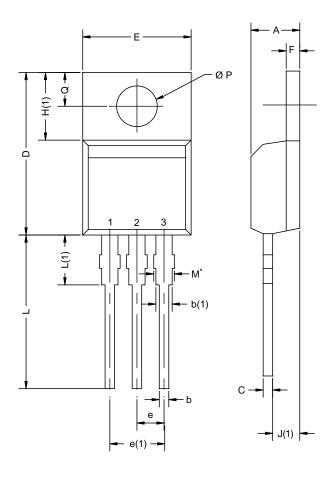
### THERMAL RATINGS
