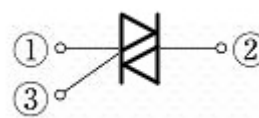

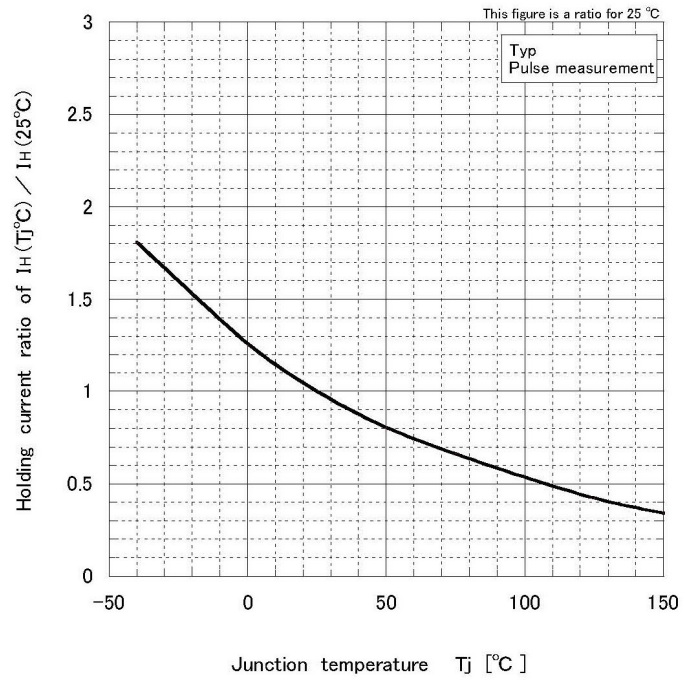




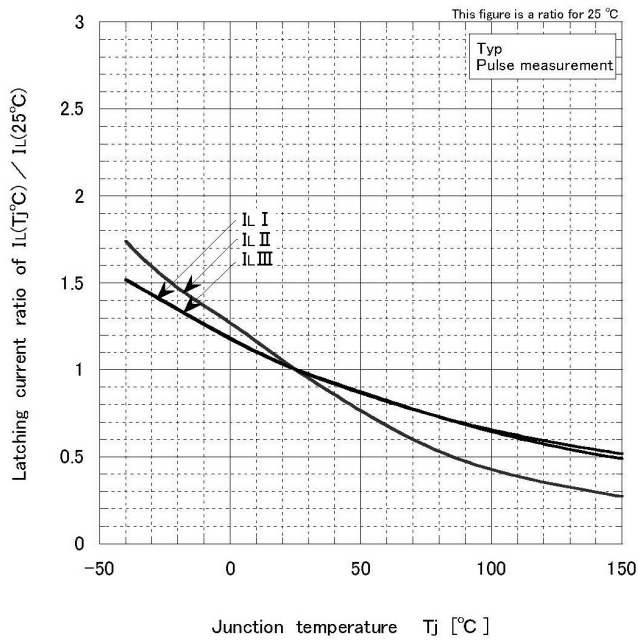
Gate trigger voltage - Junction temperature



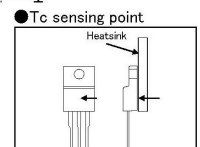
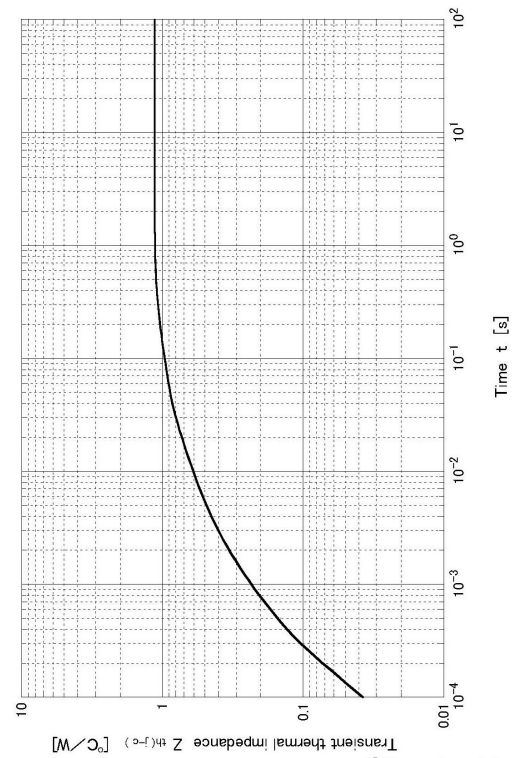
Holding current - Junction temperature

Transient thermal impedance

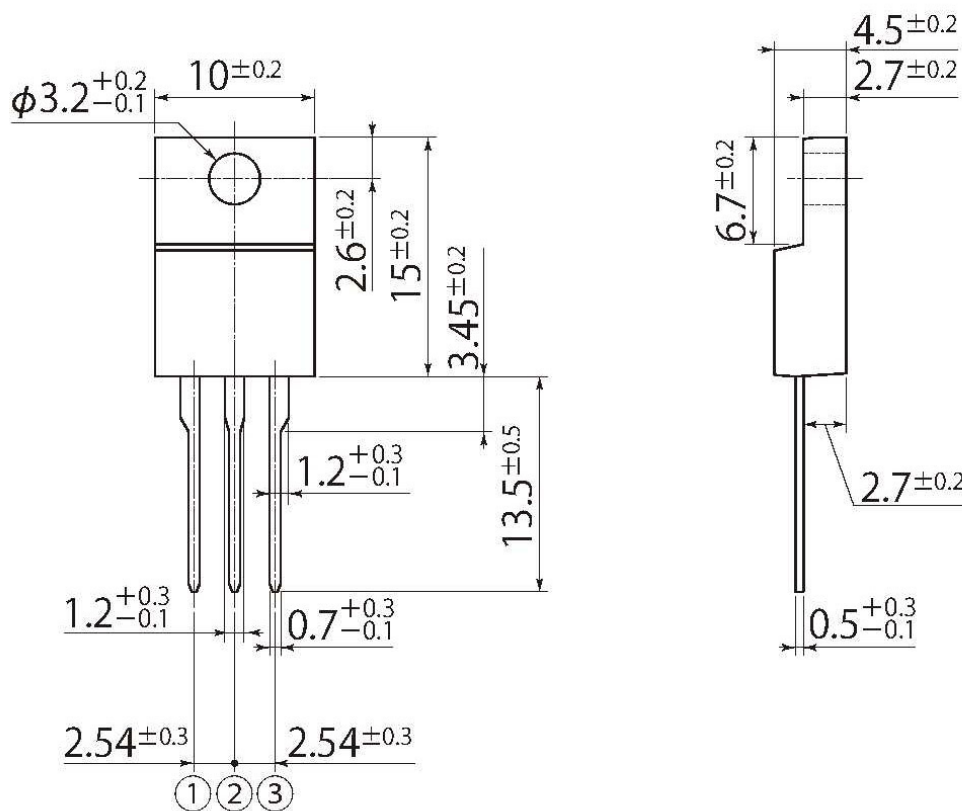
