




VGS, Gate-to-source Voltage (V) Figure 2. Transfer Characteristics




VGS, Drain-to Source Voltage Figure3.Capacitance









Tj., Junction Temperature(°C)

With Temperature




Tj, .Junction Temperature ($^{\circ}$ C)

With Temperature




IDS, Drain-Source Current (A)
Figure 7. Transconductance Variation




Vsp, Body Diode Forward Voltage Figure8.Body Diode Forward Voltage







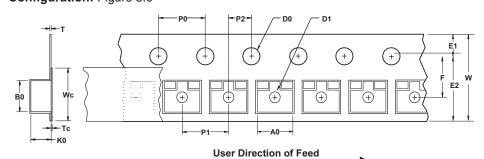

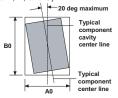

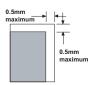


Sketch A (Side or Front Sectional View)

Component Rotation



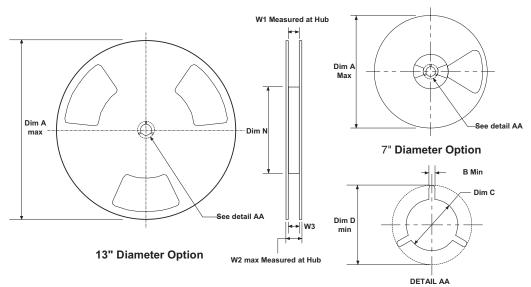
Sketch B (Top View)
