


Figure 1. Supply Current




Figure 2. Input Offset Voltage
Supply Voltage Rejection Ratio




Figure3. Input Bias Current




Figure 4. Input Offset Current




Figure 5. Open-Loop Voltage Gain




Figure6. Common Mode Rejection Ratio




Figure 7. Maximum Output Voltage




Figure8. Gain Bandwidth Product Phase Margin




Figure 10. Slew Rate




Figure 9. Input Noise Voltage




Figure 11. Total Harmonic Distortion





■ EXAMPLE OF SOLDER PADS DIMENSIONS






