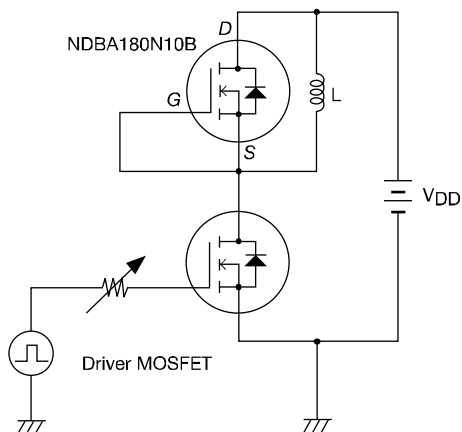
**Fig.1 Unclamped Inductive Switching Test Circuit**



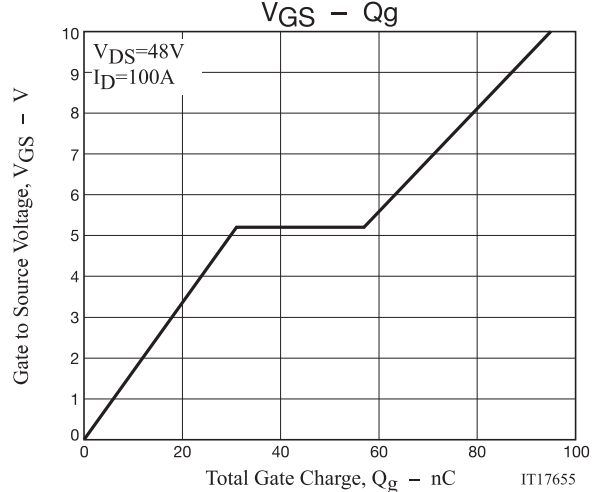
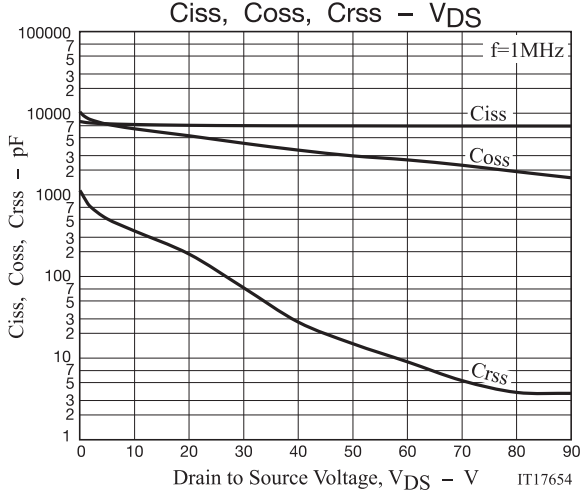
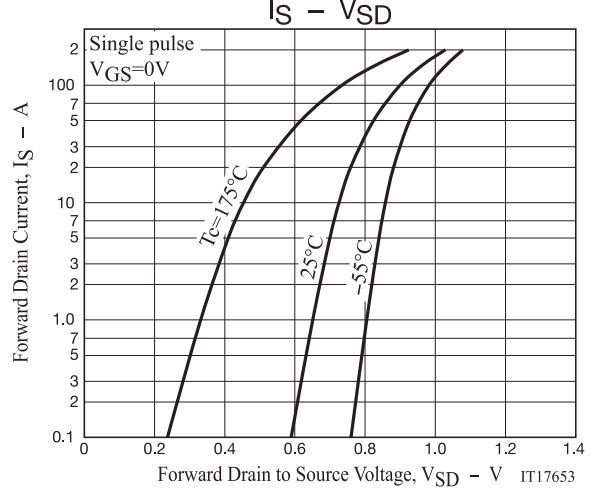
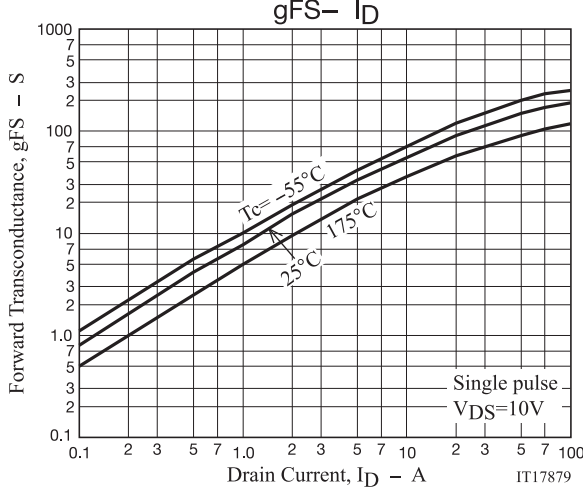
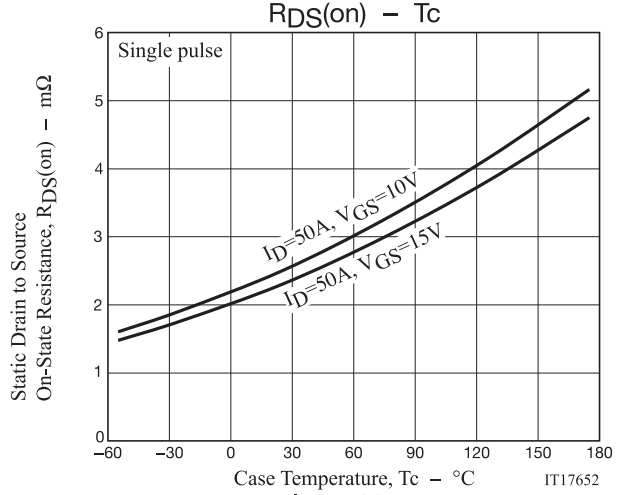
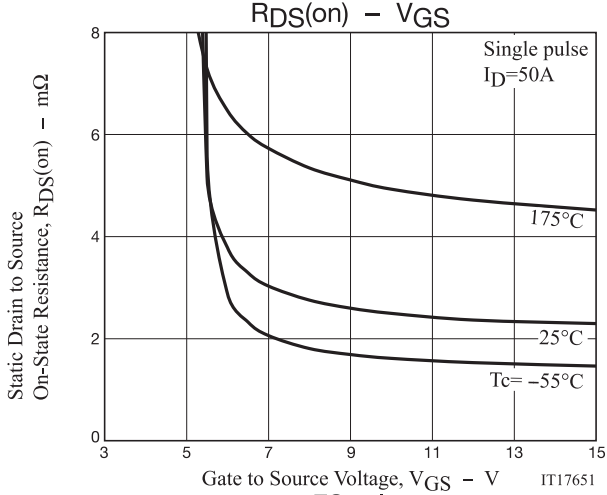
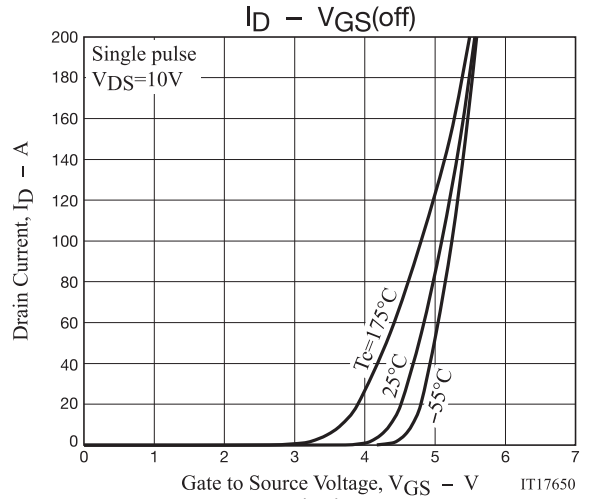
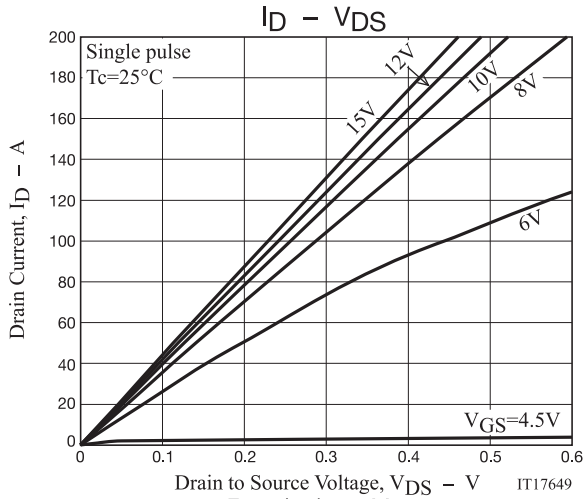
**Fig.2 Switching Time Test Circuit**



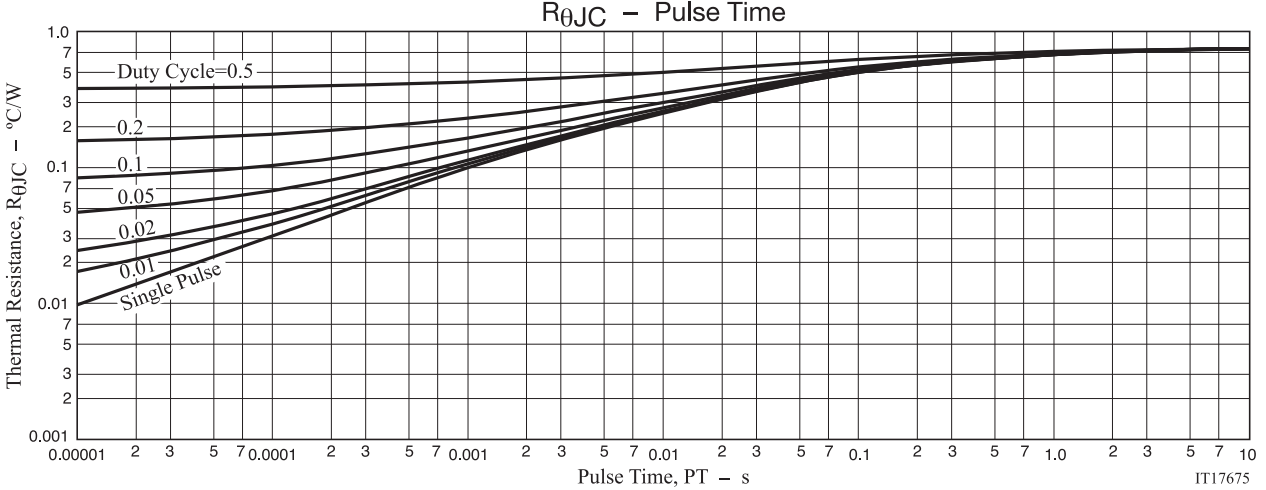
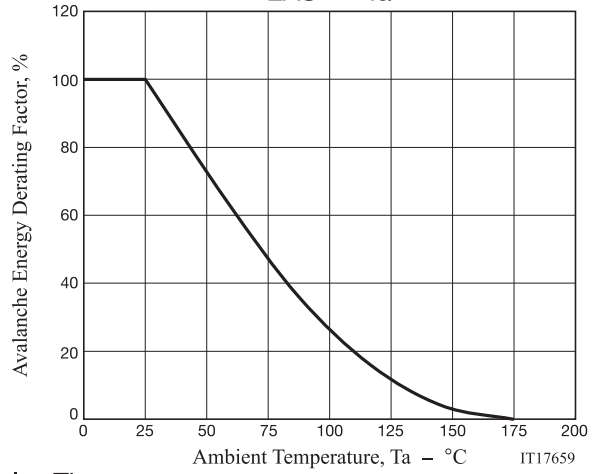
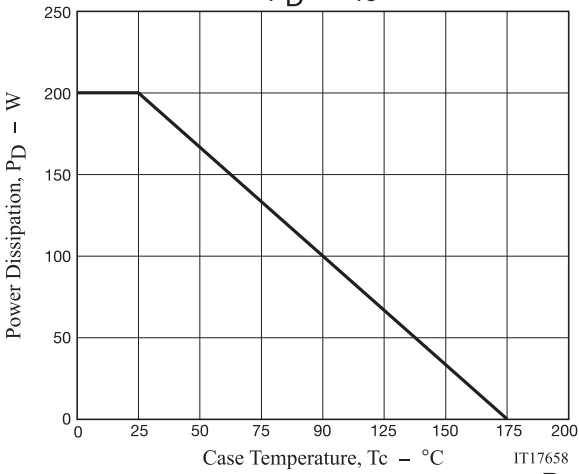
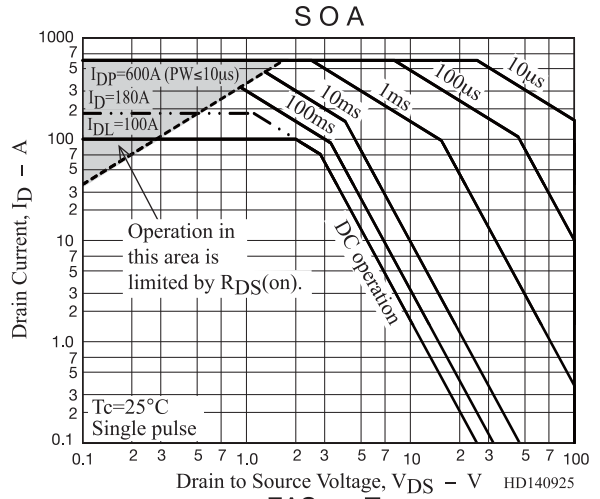
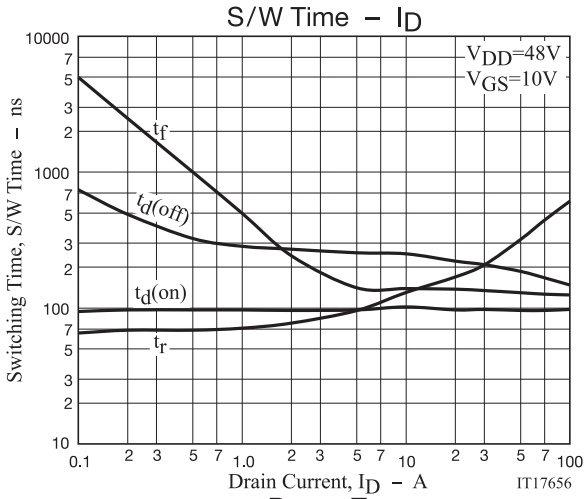
**Fig.3 Reverse Recovery Time Test Circuit**

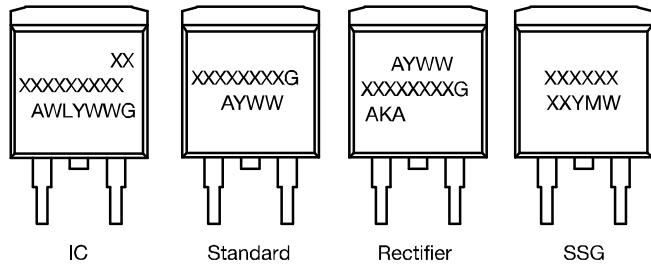
