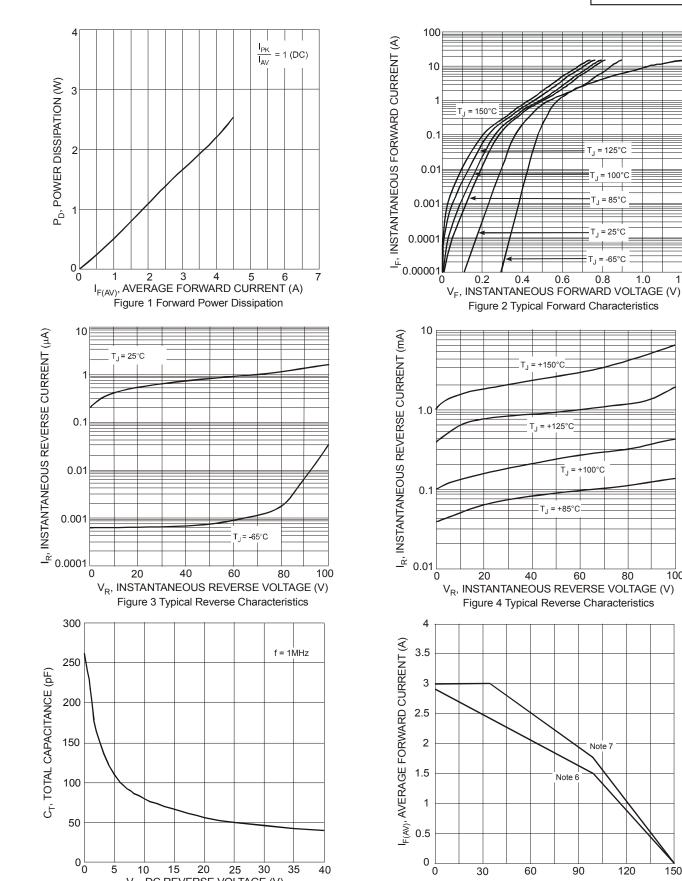

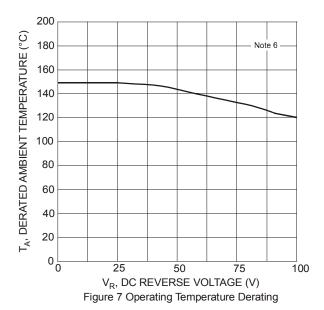

Figure 6 Forward Current Derating Curve

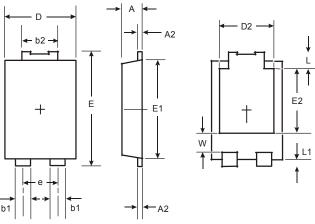

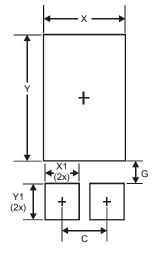
