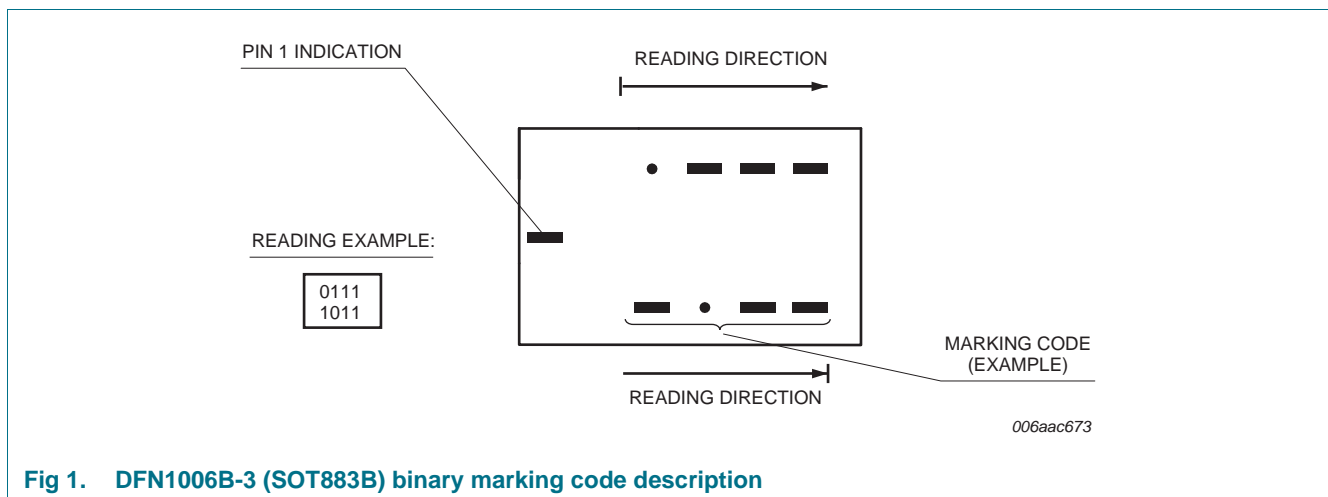

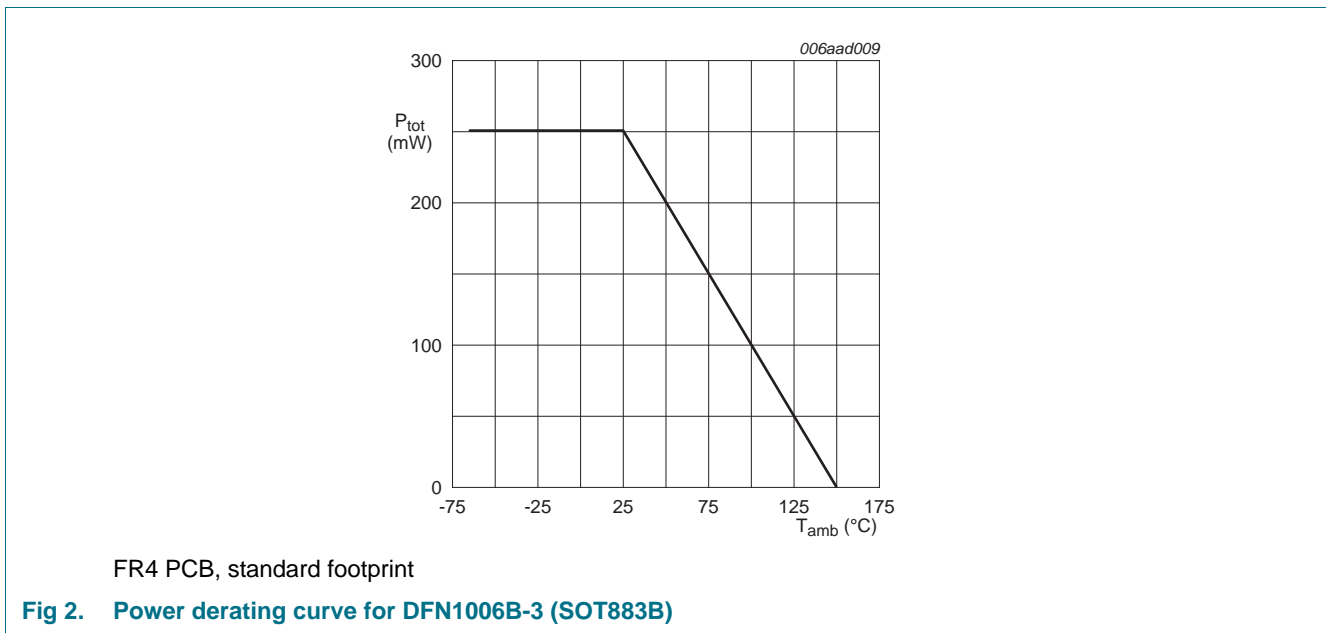

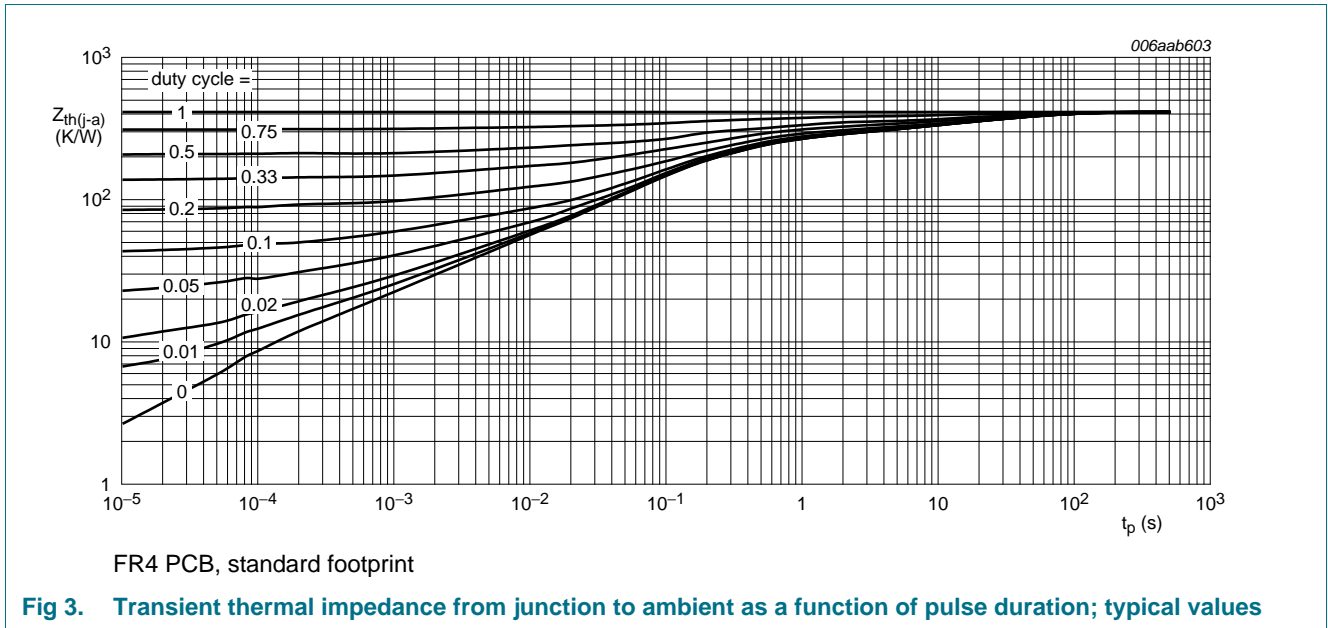

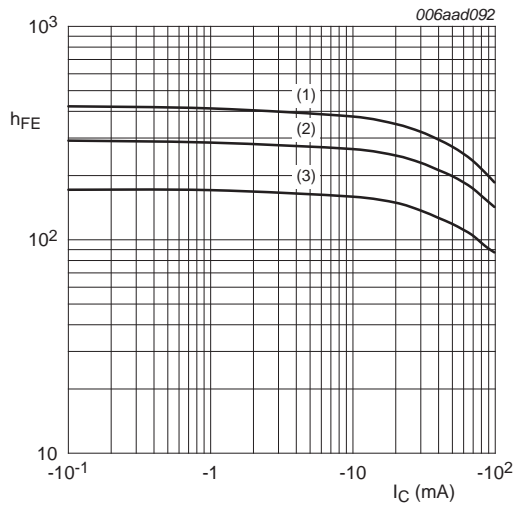

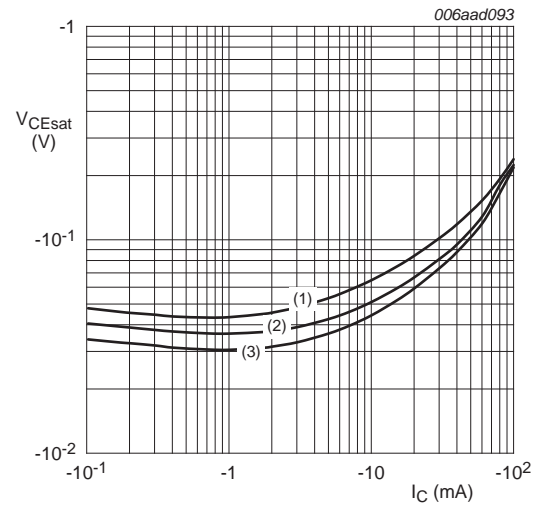

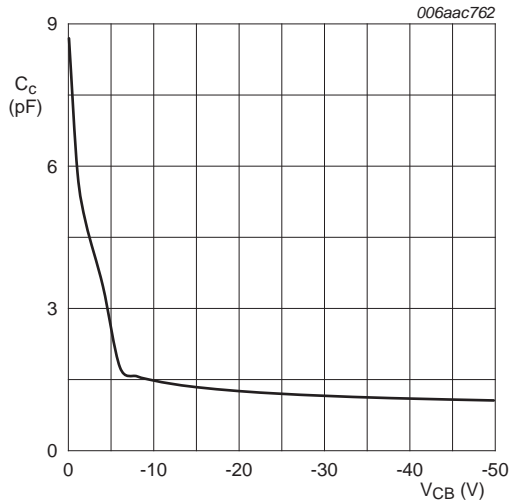

Fig 4. DC current gain as a function of collector current; typical values



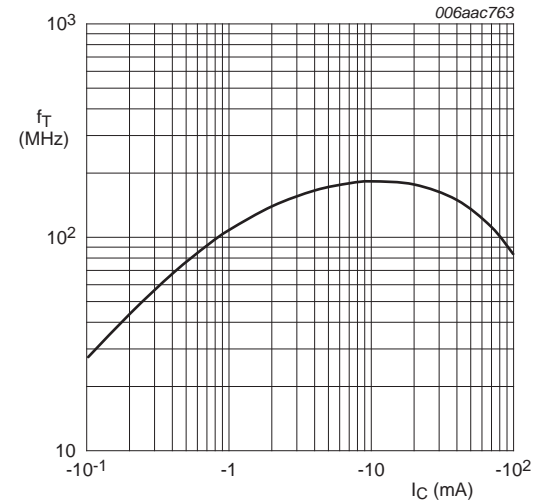

$V_{CE} = -5\text{ V}; T_{amb} = 25\text{ °C}$

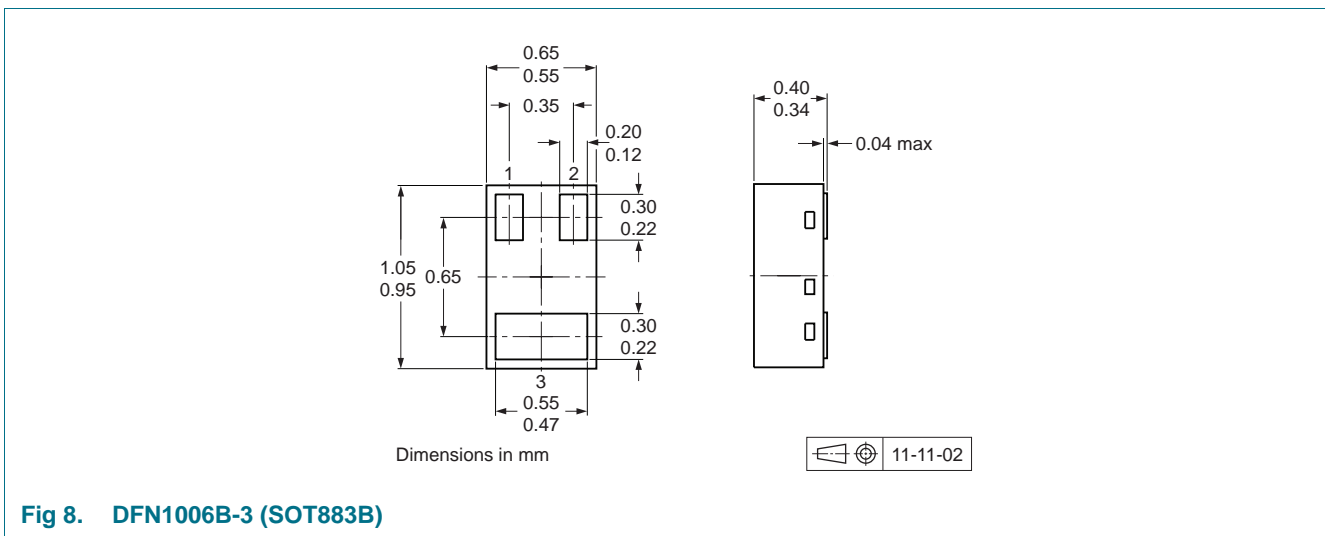
Fig 7. Transition frequency as a function of collector current; typical values of built-in transistor

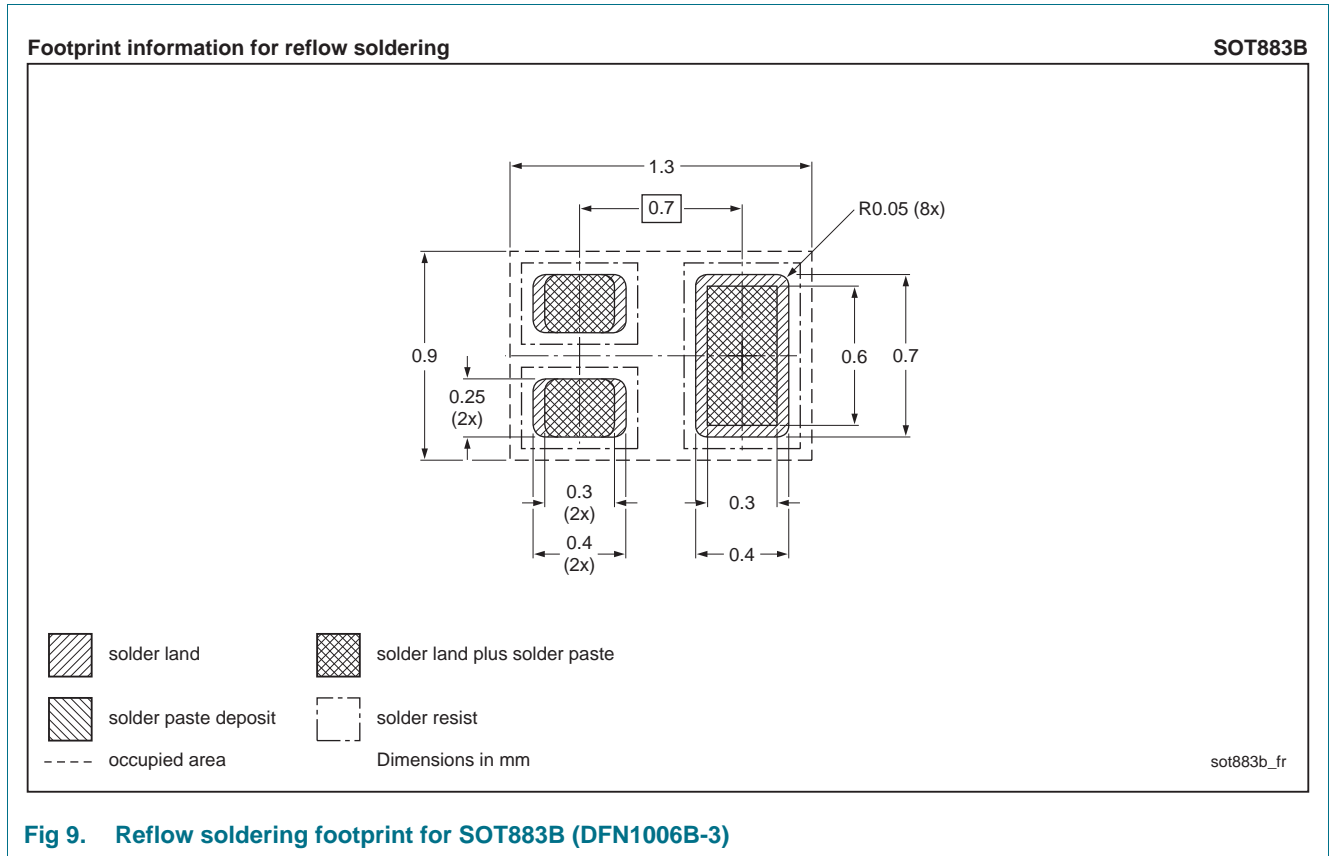
