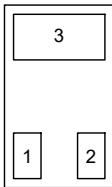
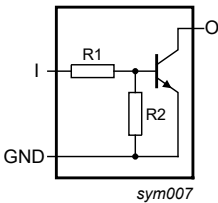

$$\frac{R_2}{R_1} = \frac{V(I_4) - V(I_3)}{R_1 \cdot (I_4 - I_3)} - 1$$

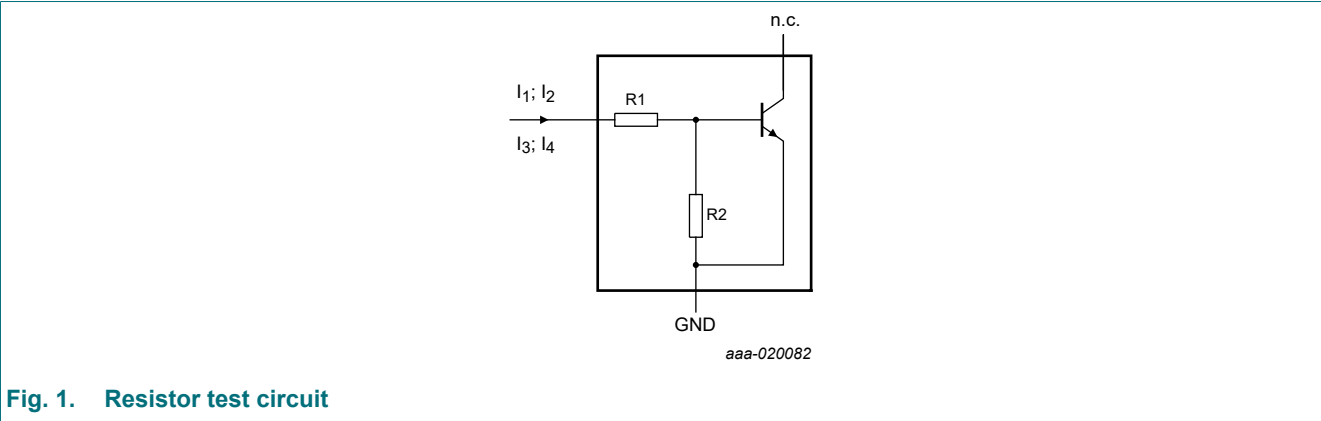


Fig. 1. Resistor test circuit

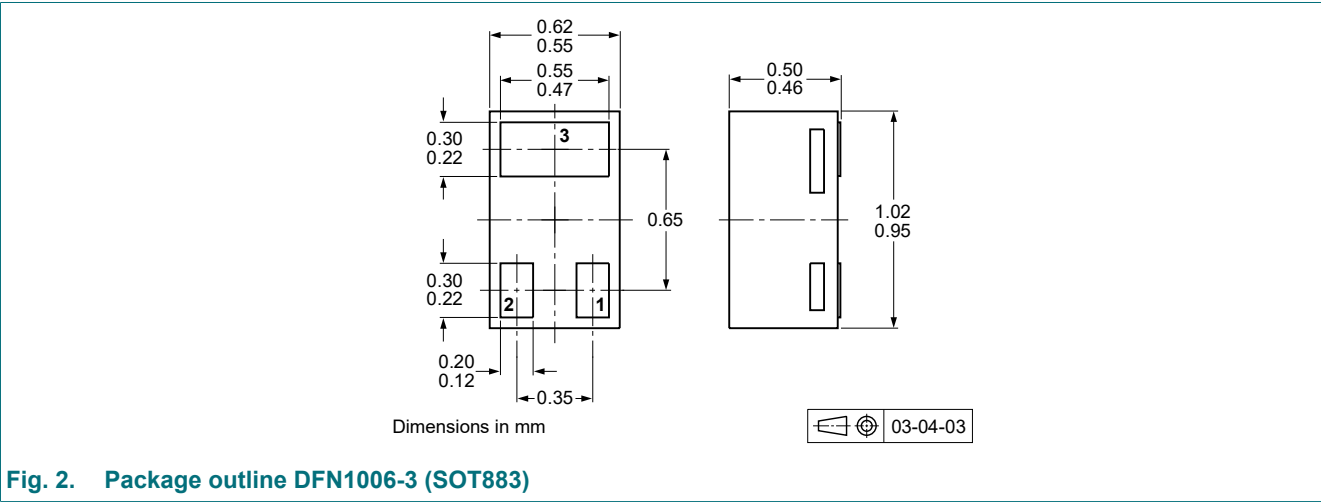


Fig. 2. Package outline DFN1006-3 (SOT883)

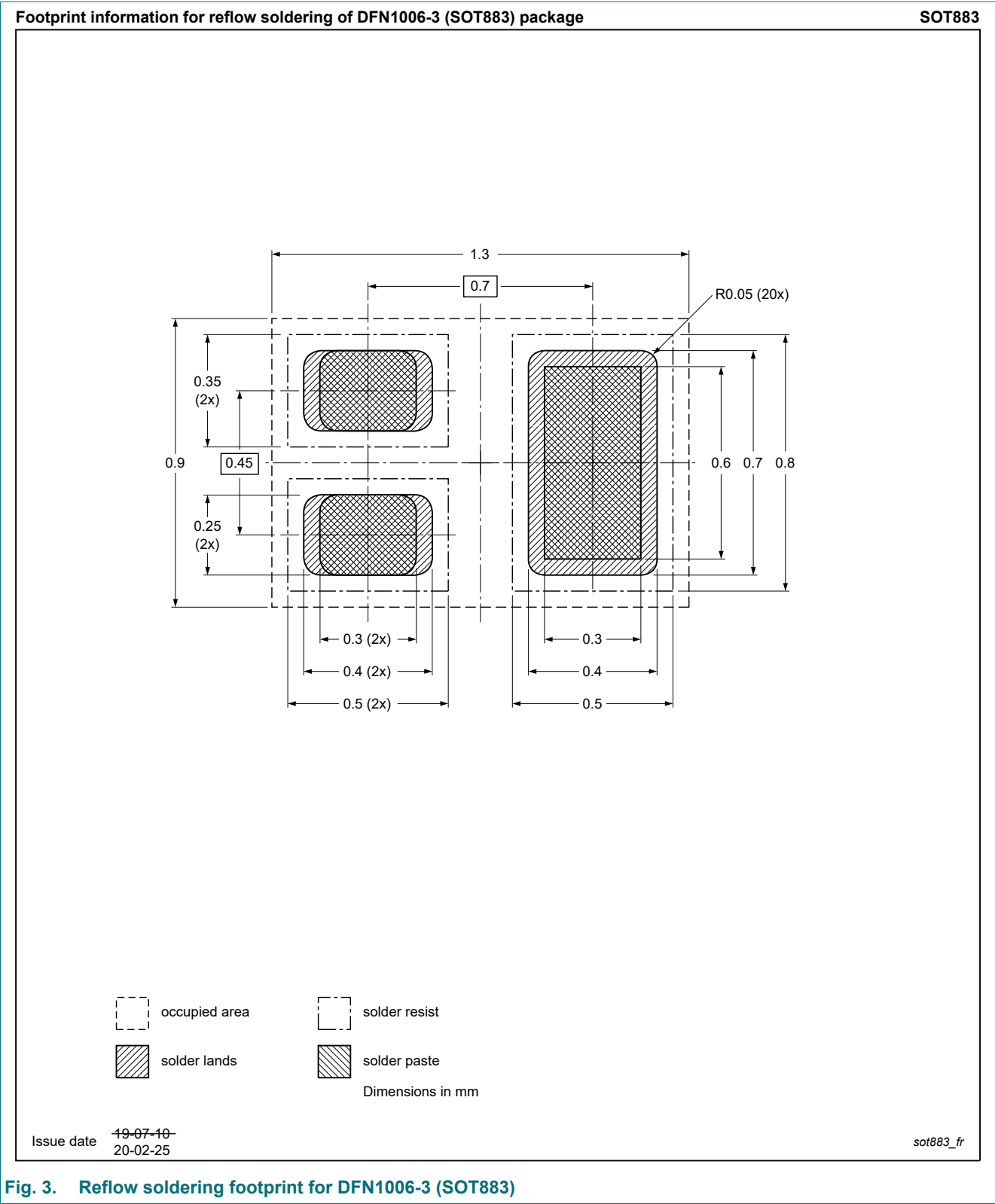


Fig. 3. Reflow soldering footprint for DFN1006-3 (SOT883)
