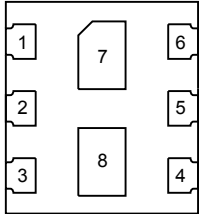
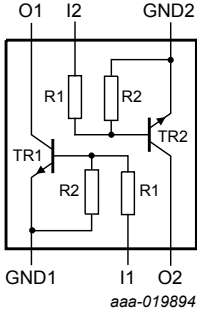

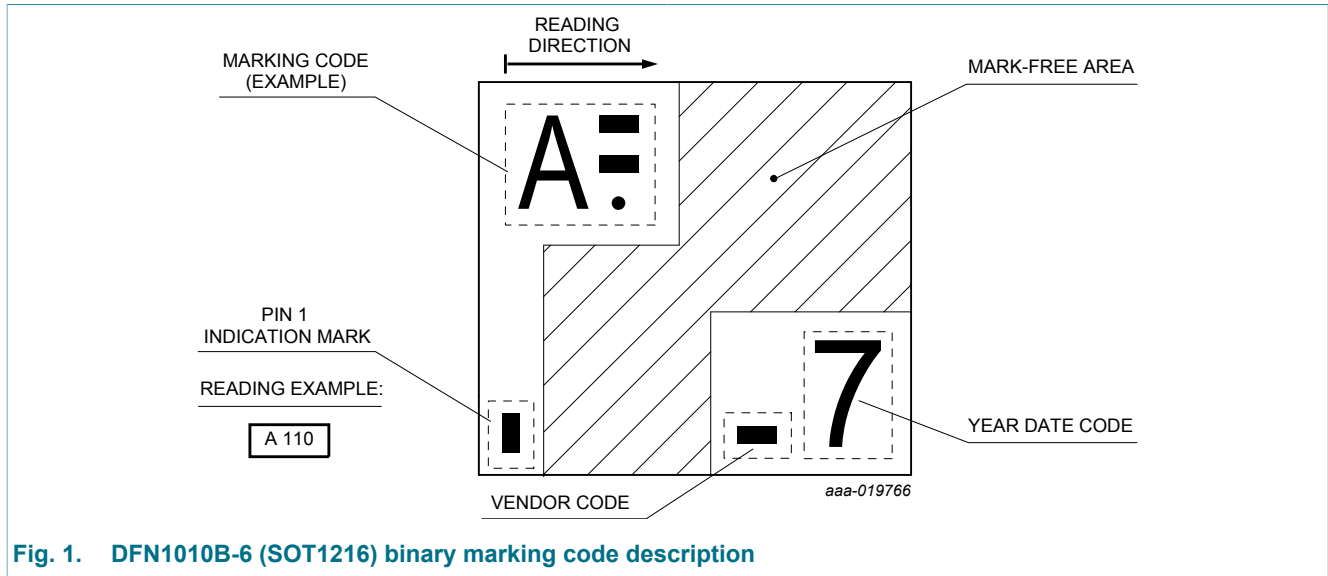


Fig. 1. DFN1010B-6 (SOT1216) binary marking code description

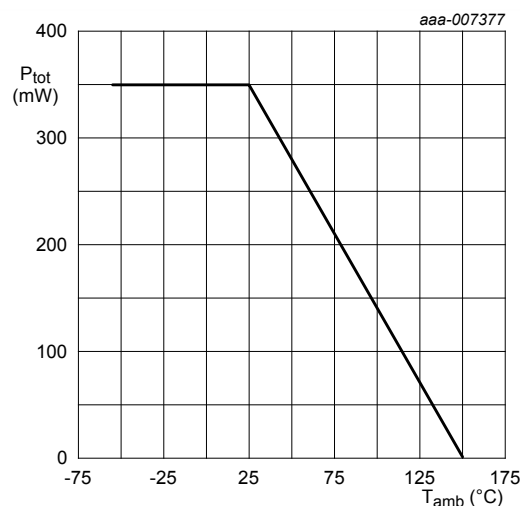

FR4 PCB, standard footprint

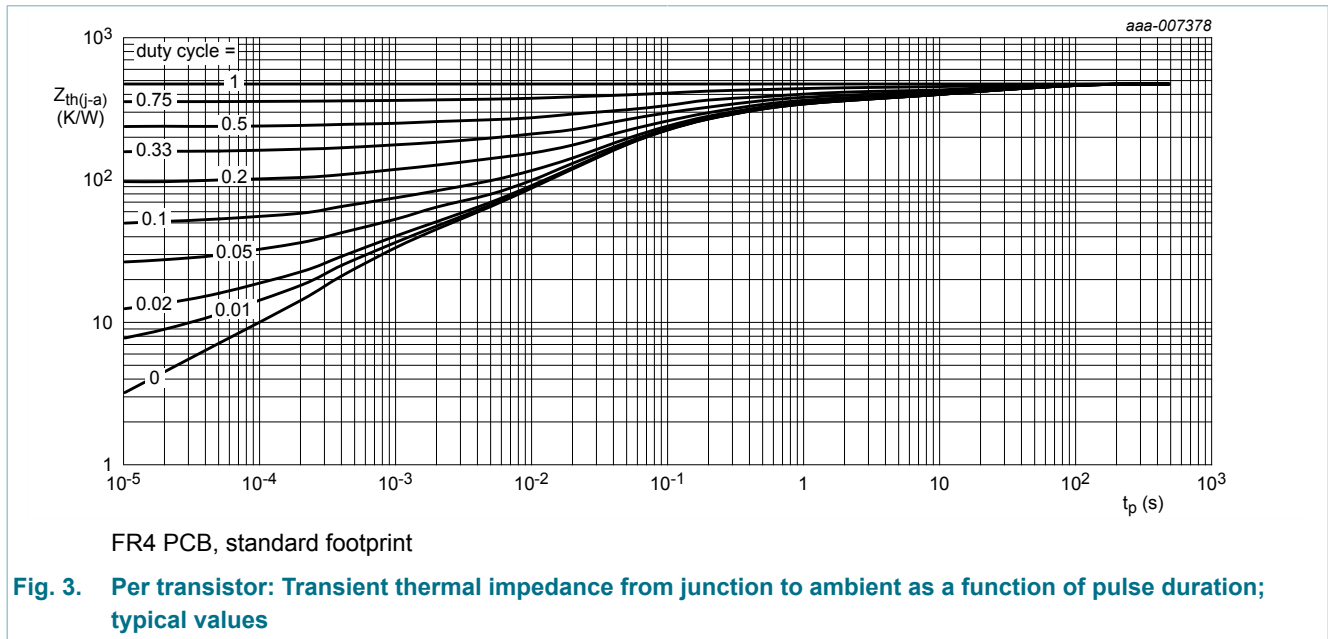
**Fig. 2. Per device: Power derating curve**

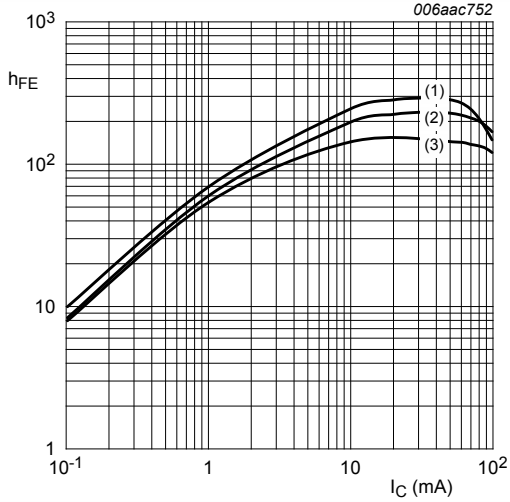

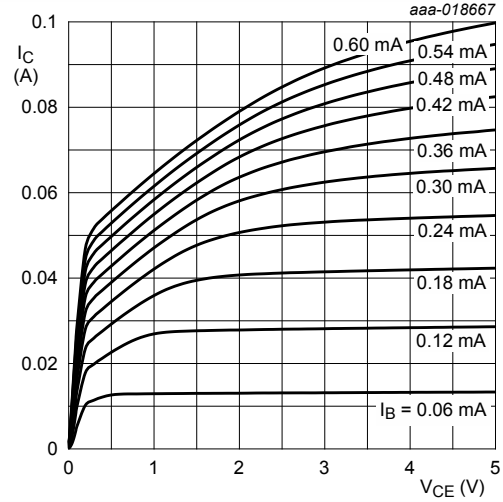

[2] Characteristics of built-in transistor



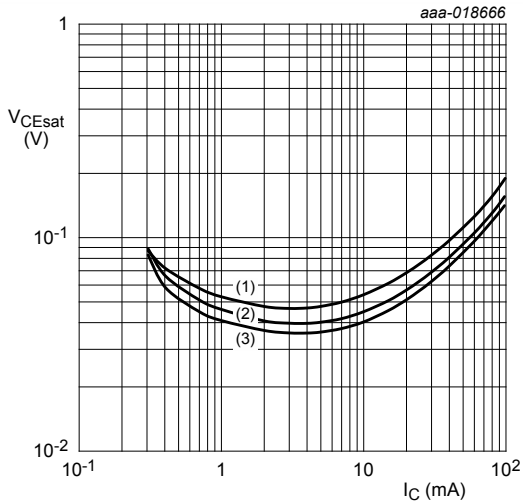

**Fig. 4. DC current gain as a function of collector current; typical values**



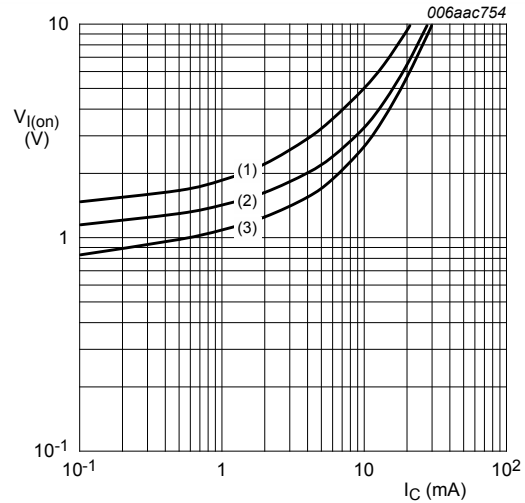

**Fig. 5. Collector current as a function of collector-emitter voltage; typical values**



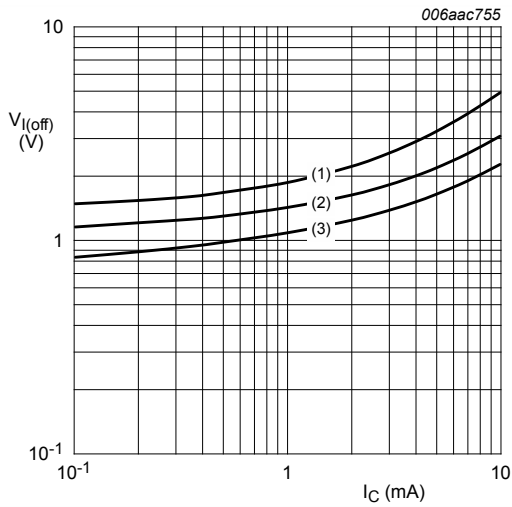

**Fig. 6. Collector-emitter saturation voltage as a function of collector current; typical values**



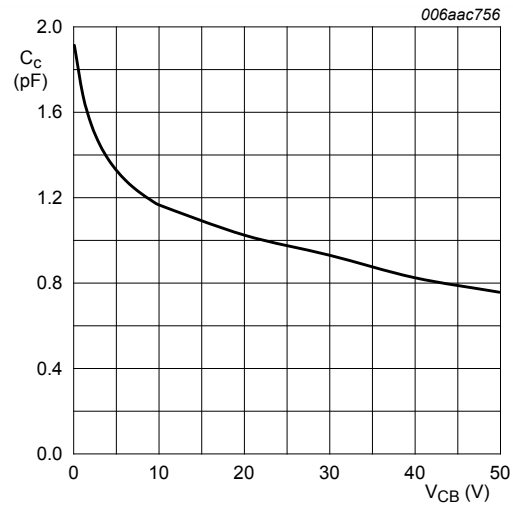

**Fig. 7. On-state input voltage as a function of collector current; typical values**



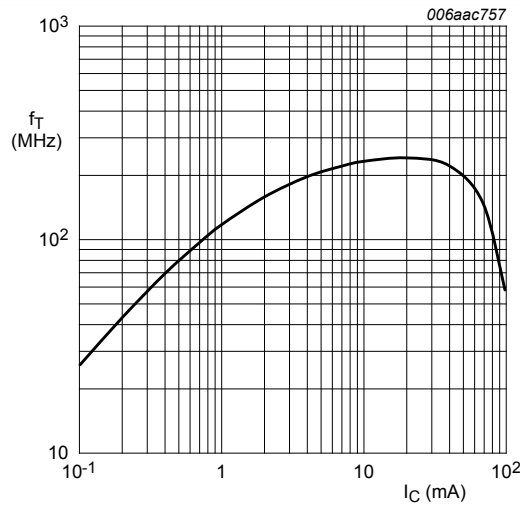

$$R1 = \frac{V(I12) - V(I11)}{I12 - I11}$$

- Calculation of bias resistor ratio (R2/R1)

$$\frac{R2}{R1} = \frac{V(I14) - V(I13)}{R1 \cdot (I14 - I13)} - 1$$

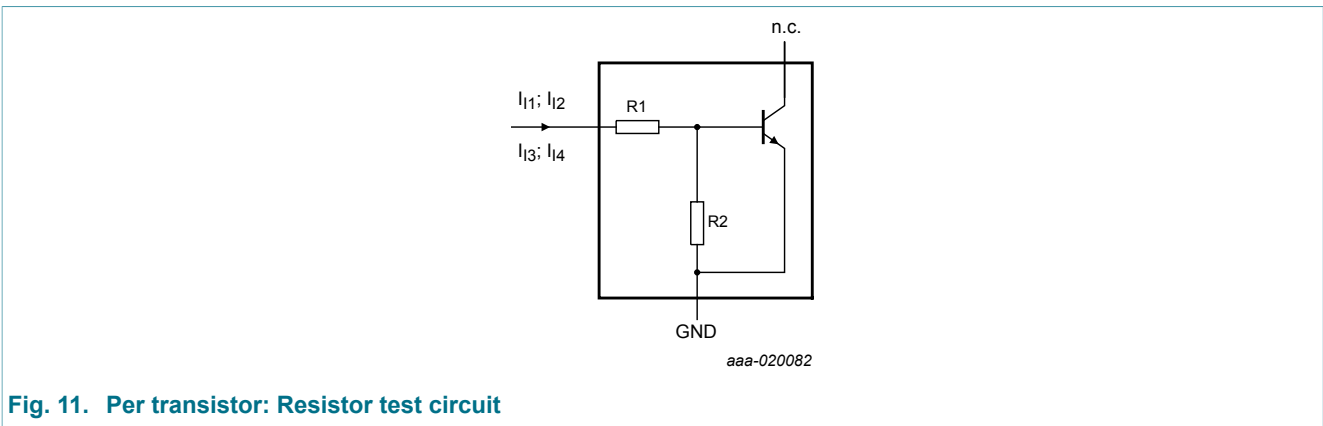


Fig. 11. Per transistor: Resistor test circuit

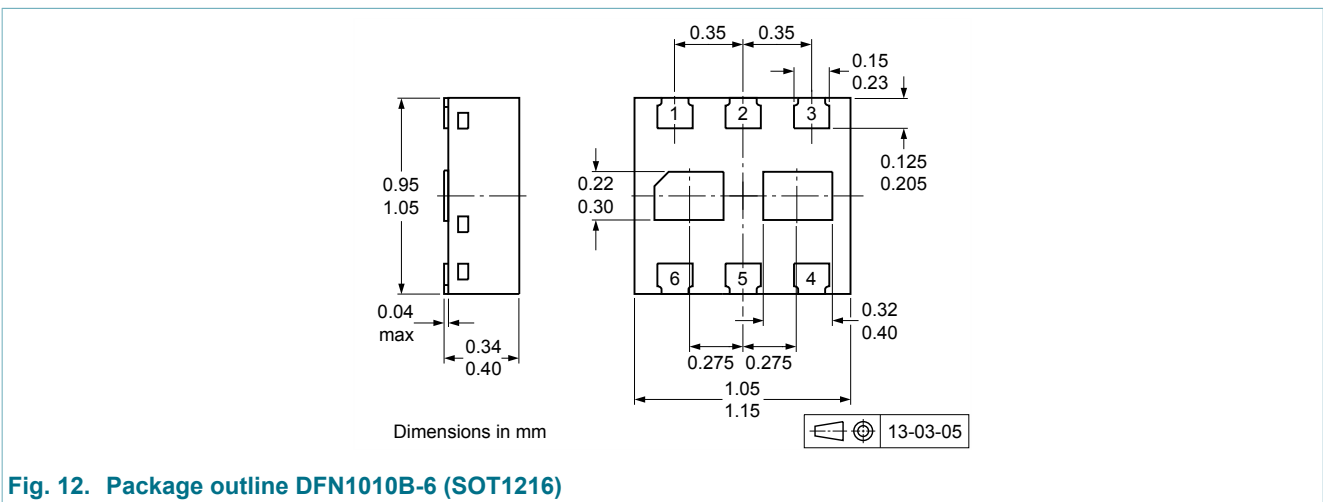


Fig. 12. Package outline DFN1010B-6 (SOT1216)

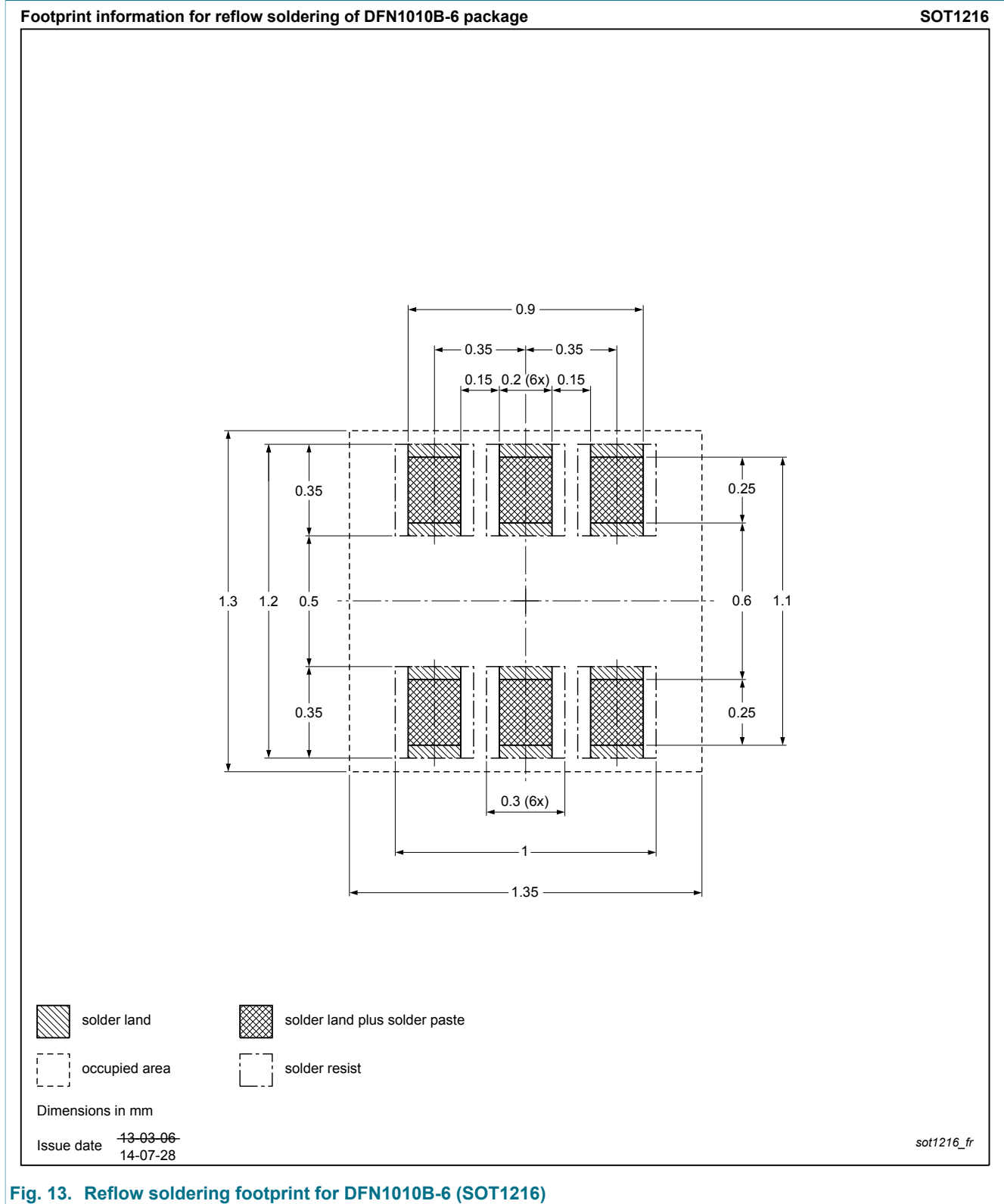


Fig. 13. Reflow soldering footprint for DFN1010B-6 (SOT1216)
