DESCRIPTION

The PS8601 and PS8601L are 8-pin high speed photocouplers containing a GaAlAs LED on input side and a PN photodiode and a high speed amplifier transistor on output side on one chip. The PS8601 is in a plastic DIP (Dual Inline Package). The PS8601L is lead bending type (Gull wing) for surface mount.





* PACKAGE DIMENSIONS (UNIT: mm)




Lead Bending Type








USAGE CAUTIONS

- 1. This product is weak for static electricity by designed with high-speed integrated circuit so protect against static electricity when handling.
- 2. By-pass capacitor of more than 0.1 μ F is used between Vcc and GND near device. Also, ensure that the distance between the leads of the photocoupler and capacitor is no more than 10 mm.
- 3. Avoid storage at a high temperature and high humidity.


TYPICAL CHARACTERISTICS (TA = 25 °C, unless otherwise specified)

1. Recommended soldering conditions


(1) Infrared reflow soldering

- Peak reflow temperature
- Time of peak reflow temperature

Avoid removing the residual flux with freon-based and chlorine-based cleaning solvent.

2. Cautions regarding noise

Be aware that when voltage is applied suddenly between the photocoupler's input and output or between collector-emitters at startup, the output side may enter the on state, even if the voltage is within the absolute maximum ratings.
