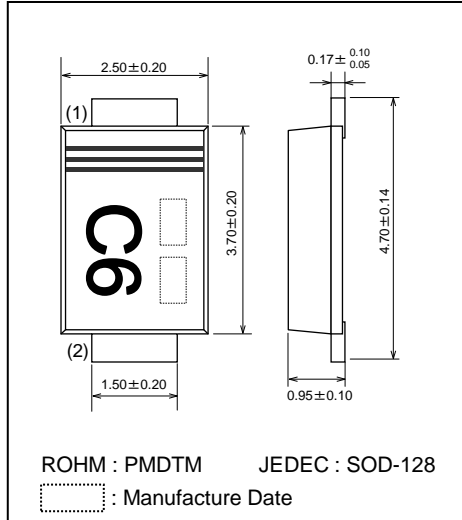

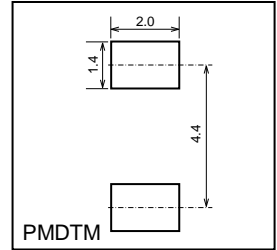

Silicon epitaxial planar type

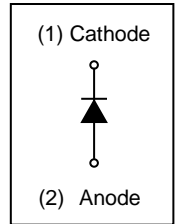

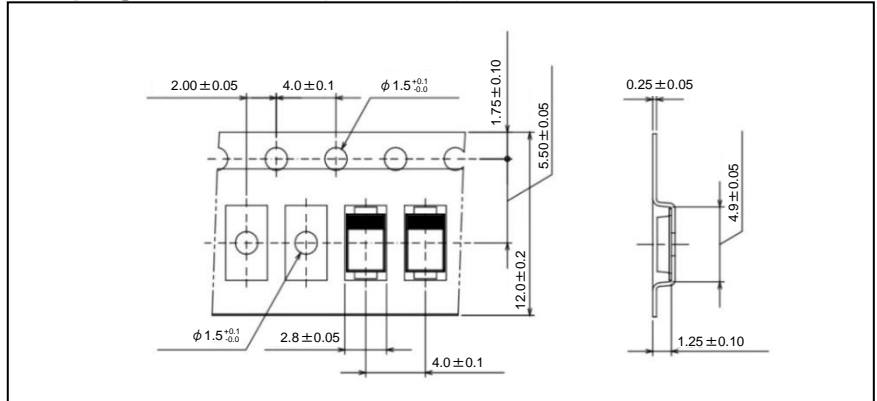
●Land Size Figure (Unit : mm)

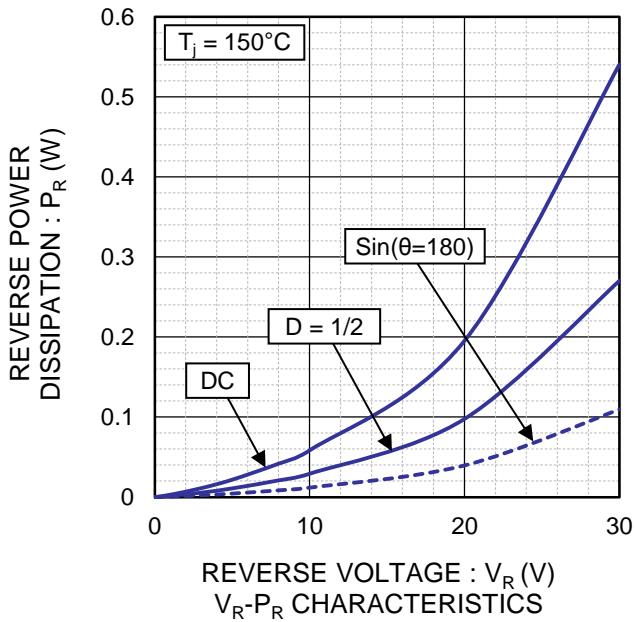
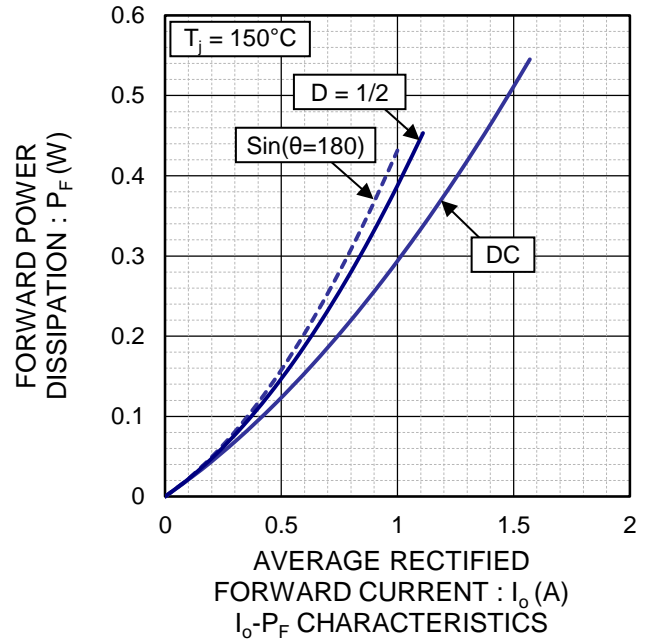
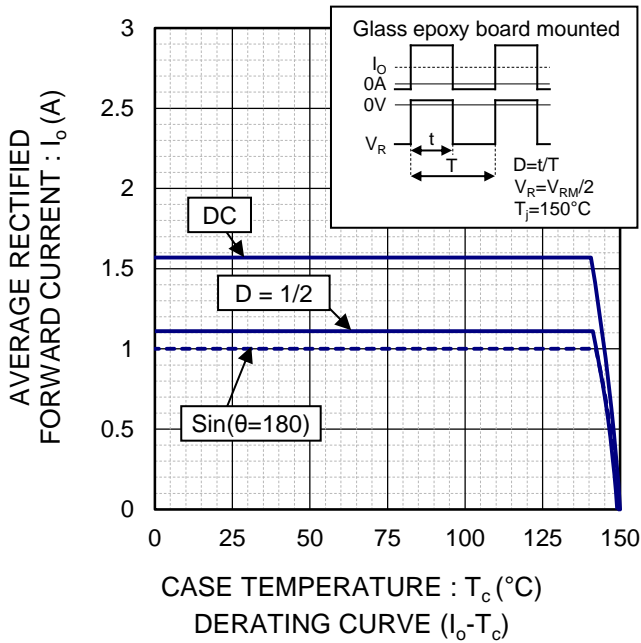
●Electrical Characteristic Curves
