



Fig.1 Power Dissipation Derating Curve





Fig.4 Avalanche Current vs Inductive Load






Fig.5 Avalanche Energy Derating Curve vs Junction Temperature





Fig.7 Typical Output Characteristics(II)





Fig.14 Static Drain - Source On - State Resistance vs. Junction Temperature




Fig.15 Static Drain - Source On - State Resistance vs. Drain Current(II)






Fig.16 Drain Current Derating Curve





Fig.17 Typical Capacitance








Fig21 Reverse Recovery Time

Fig.1-1 Switching Time Measurement Circuit




Fig.2-1 Gate Charge Measurement Circuit

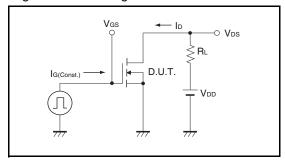


Fig.3-1 Avalanche Measurement Circuit




Fig.1-2 Switching Waveforms




Fig.2-2 Gate Charge Waveform






Fig.3-2 Avalanche Waveform
