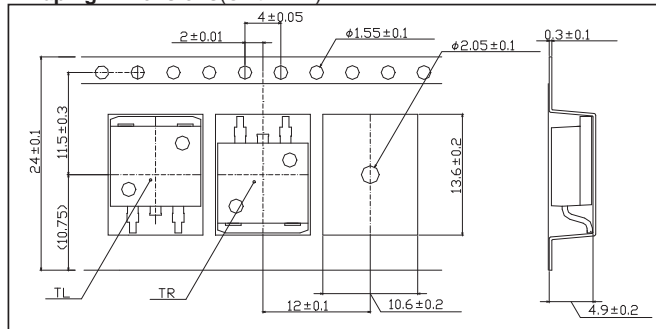

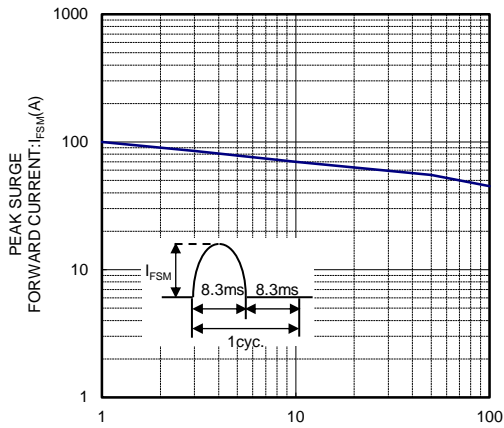




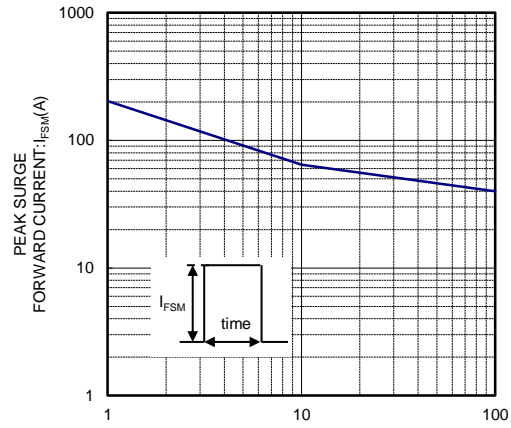
I_{FSM} DISPERSION MAP



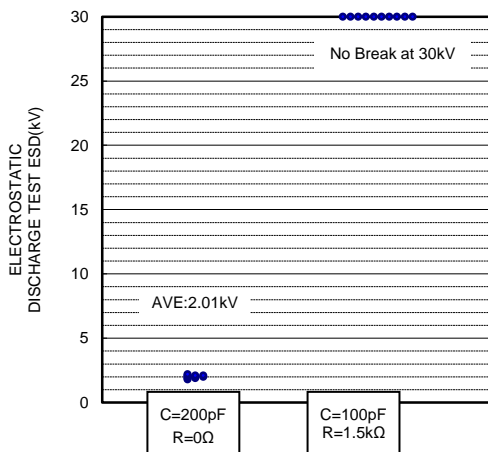
t_{rr} DISPERSION MAP



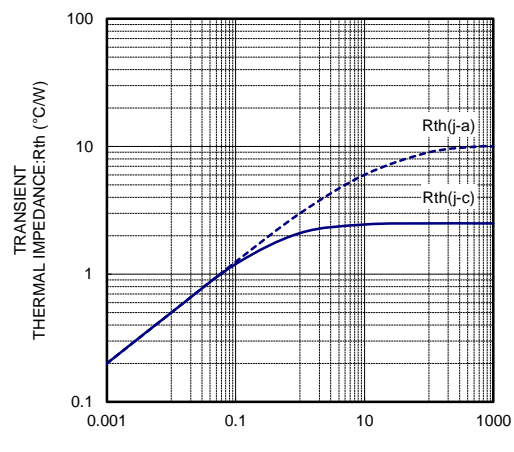
I_{FSM} CYCLE CHARACTERISTICS



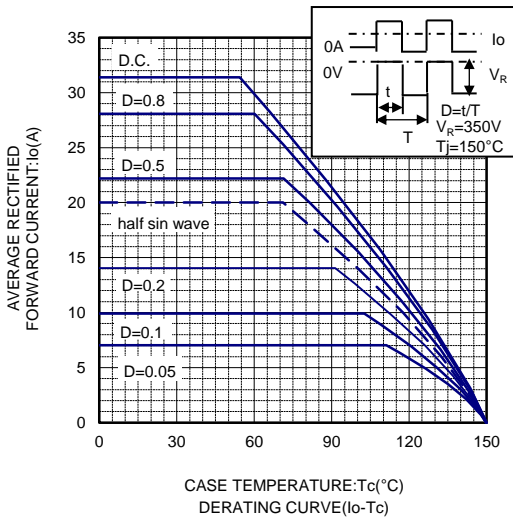
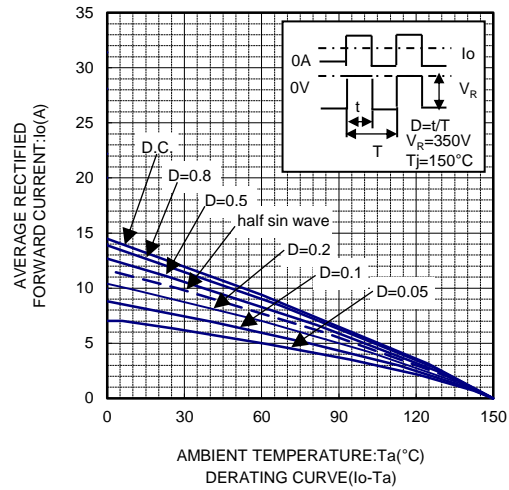
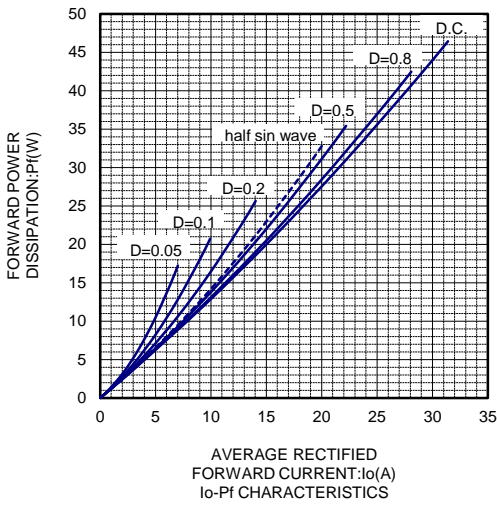
I_{FSM} - t CHARACTERISTICS
