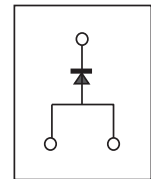

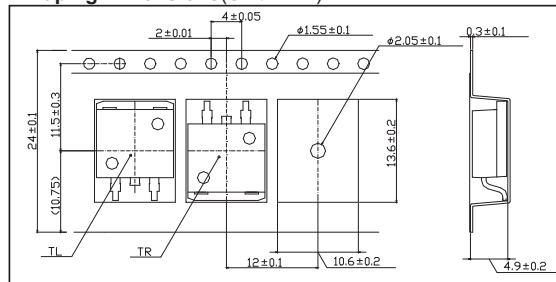

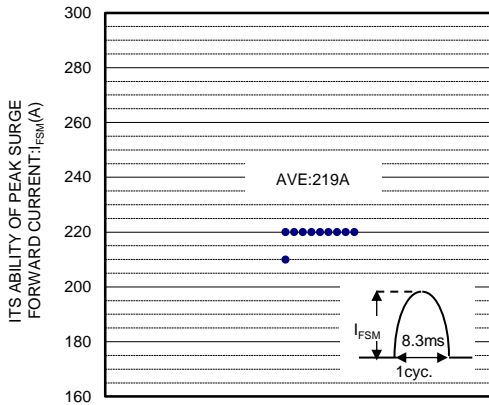
V_F DISPERSION MAP



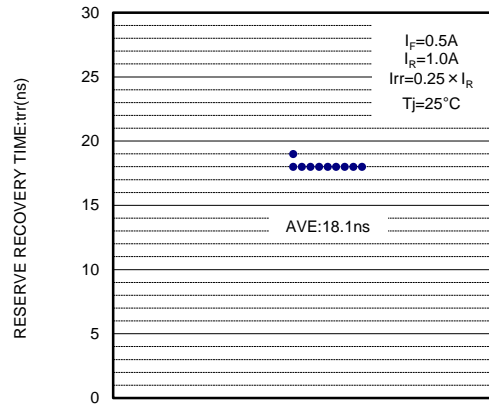
I_R DISPERSION MAP



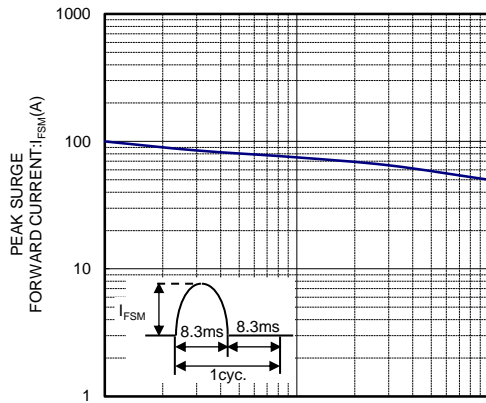
C_t DISPERSION MAP



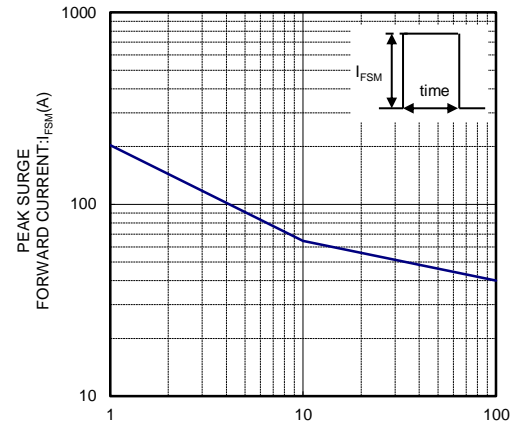
I_{FSM} DISPERSION MAP



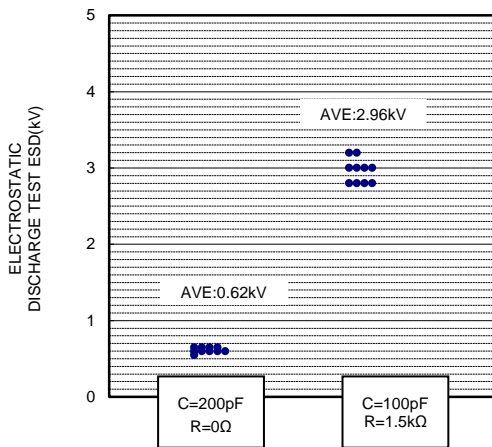
t_{rr} DISPERSION MAP



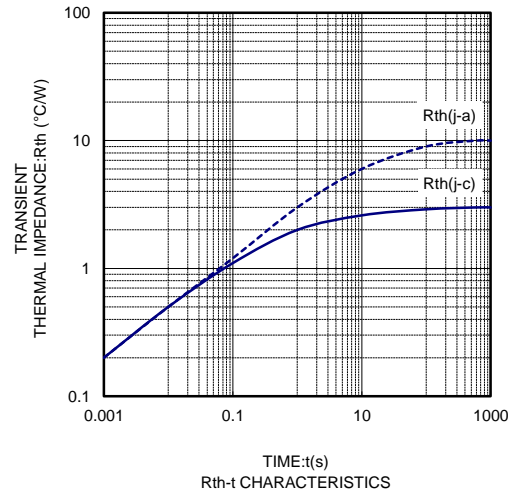
NUMBER OF CYCLES
 I_{FSM} -CYCLE CHARACTERISTICS



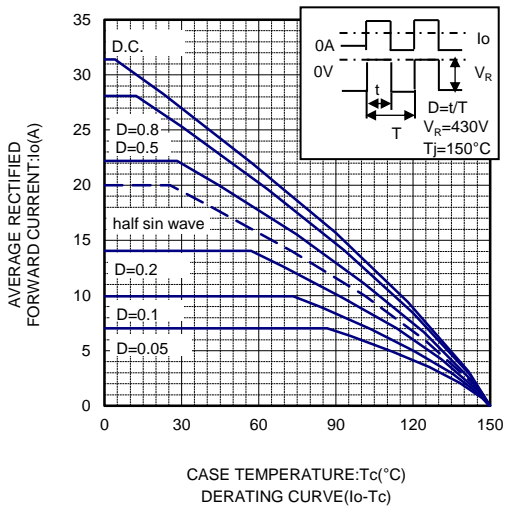
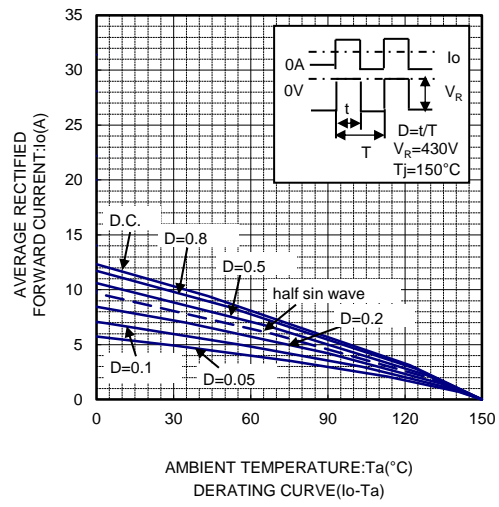
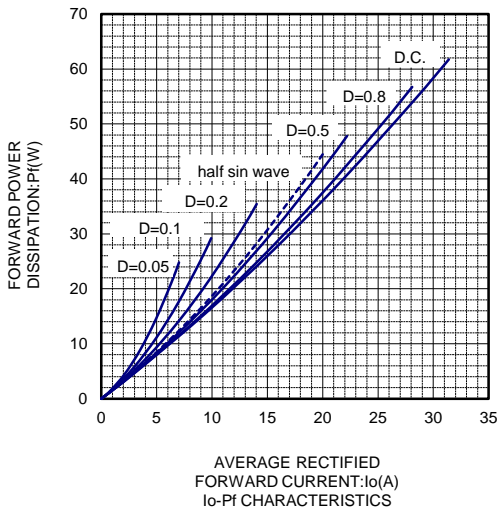
