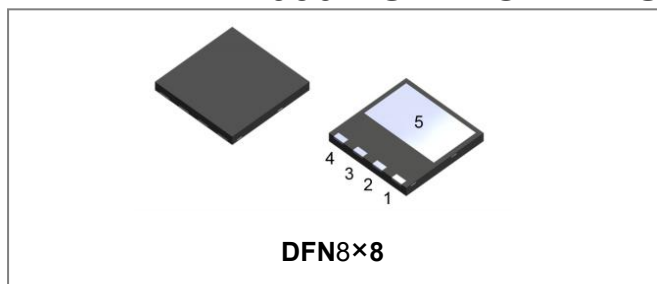


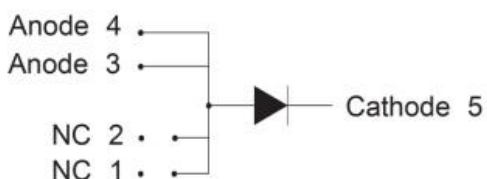
S3D06065L 650V SiC POWER SCHOTTKY RECTIFIER

S3D06065L is a SiC Schottky rectifier packaged in DFN8x8 case. The device is a high voltage Schottky rectifier that has very low total conduction losses and very stable switching characteristics over temperature extremes. The S3D06065L is ideal for energy sensitive, high frequency applications in challenging environments.

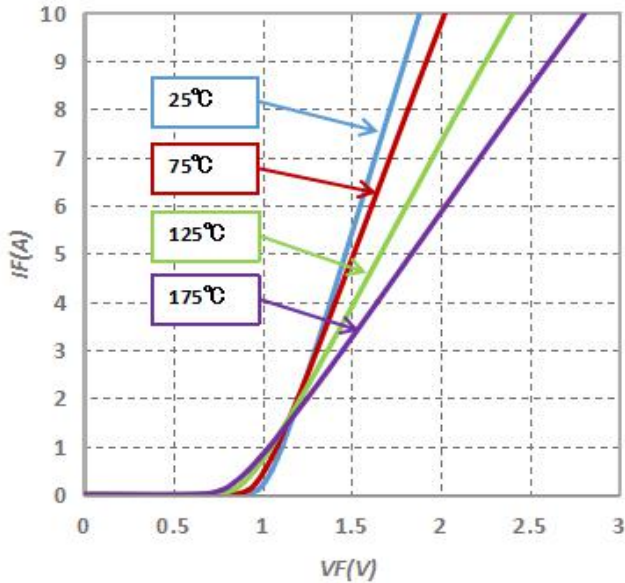


Fig.1-Typical Forward Voltage Characteristics

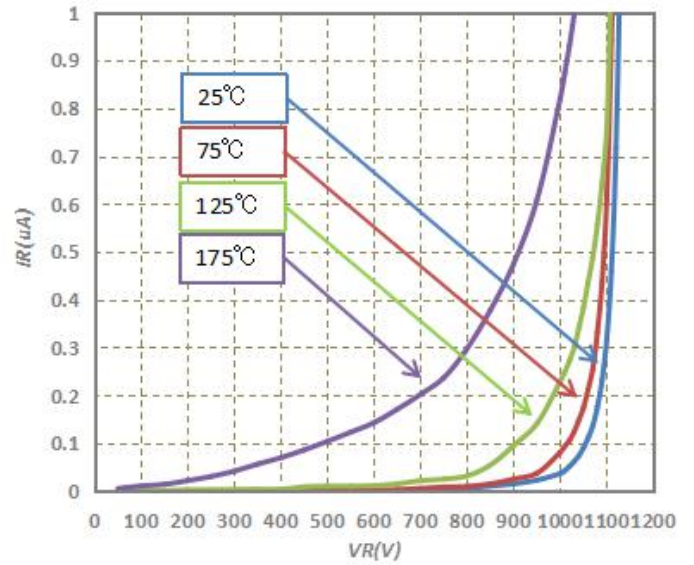


Fig.2-Typical Reverse Characteristics

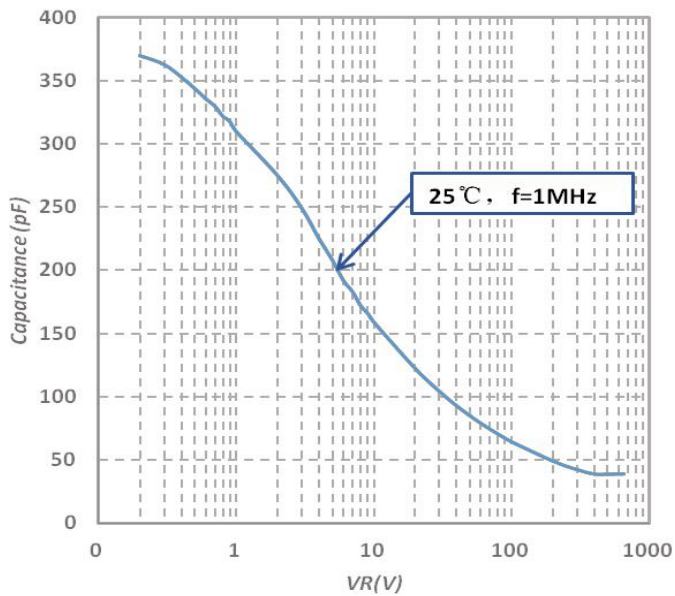


Fig.3-Capacitance vs. Reverse Voltage

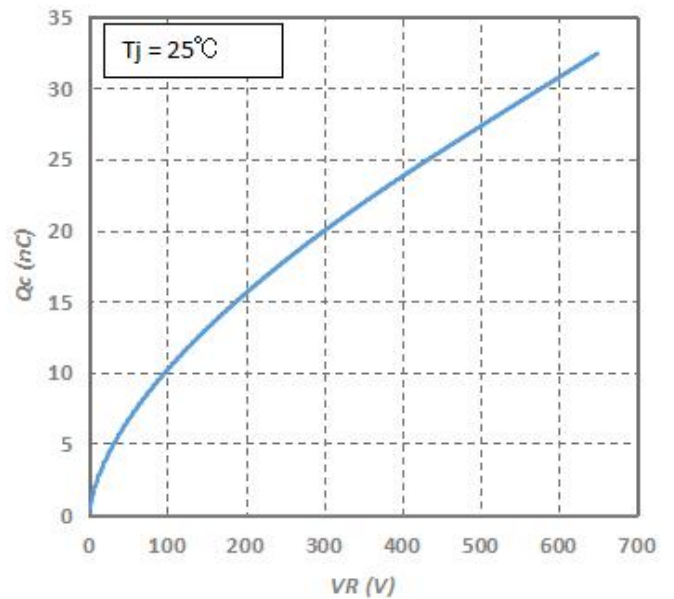


Fig.4-Total Capacitance Charge vs. Reverse Voltage

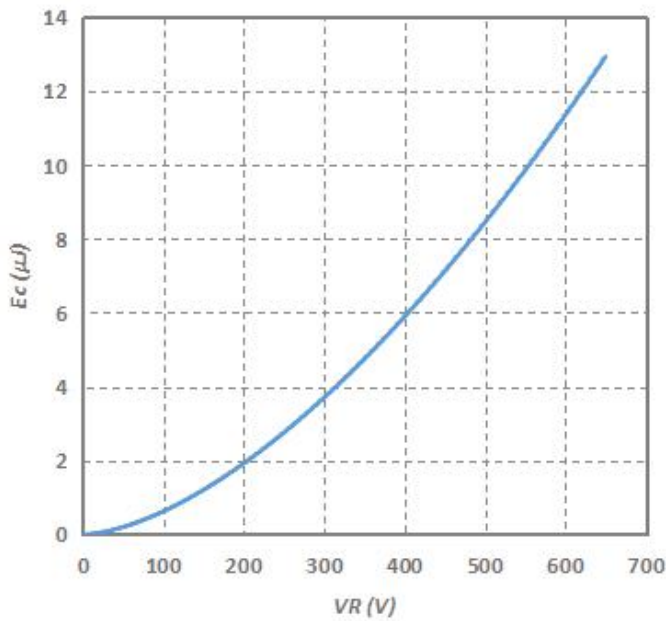


Fig.5-Capacitance Stored Energy

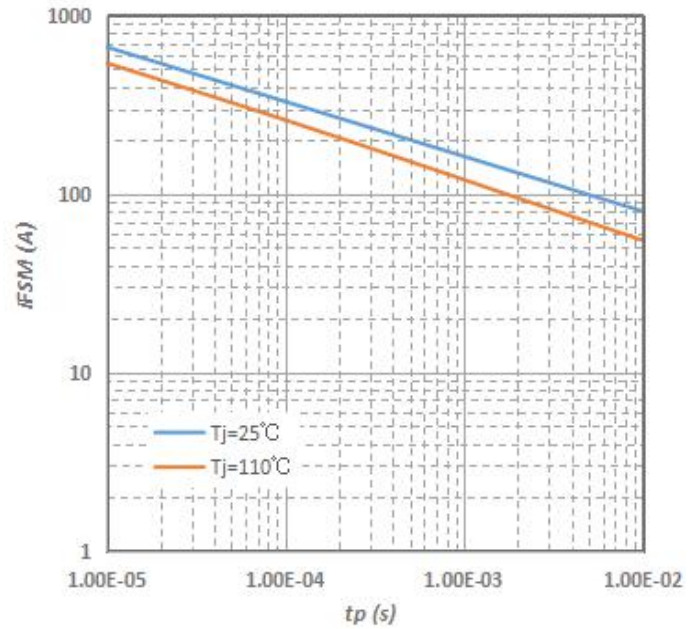


Fig.6-Non-repetitive peak forward surge current versus pulse duration (sinusoidal waveform)

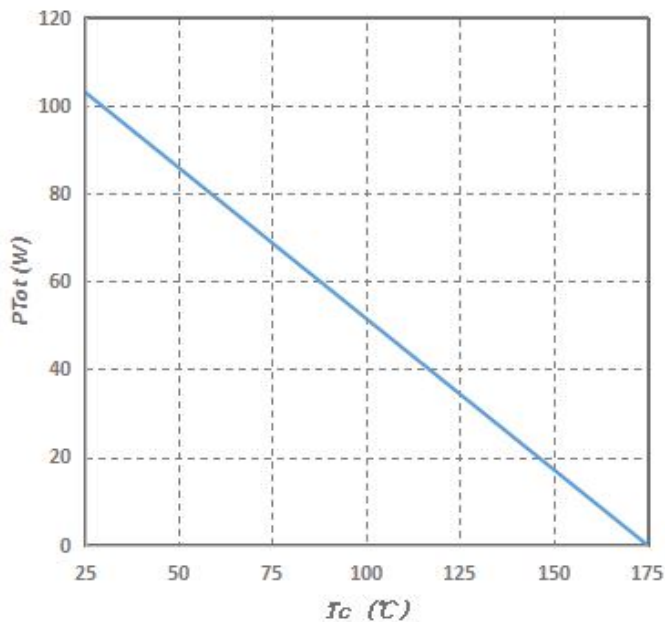


Fig.7-Power Derating

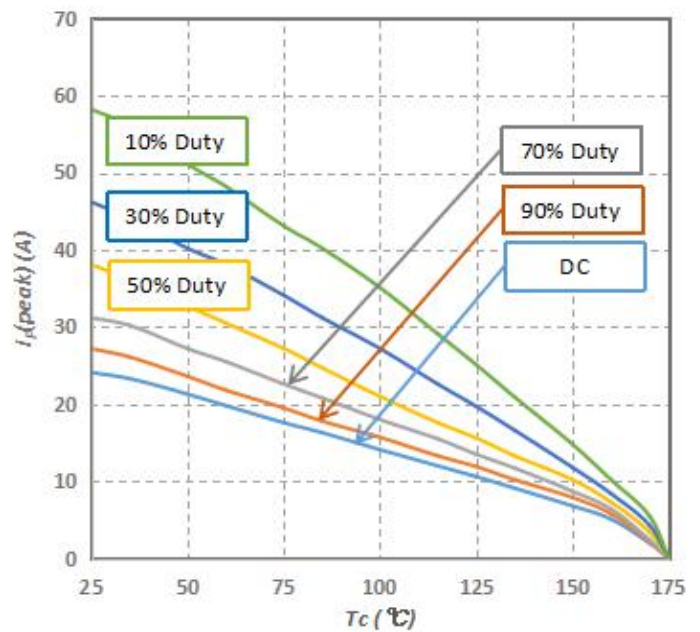
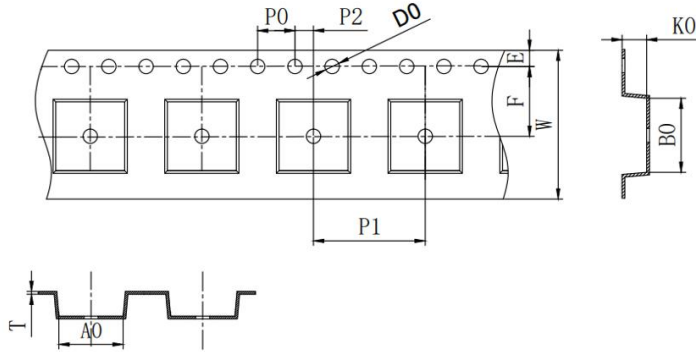


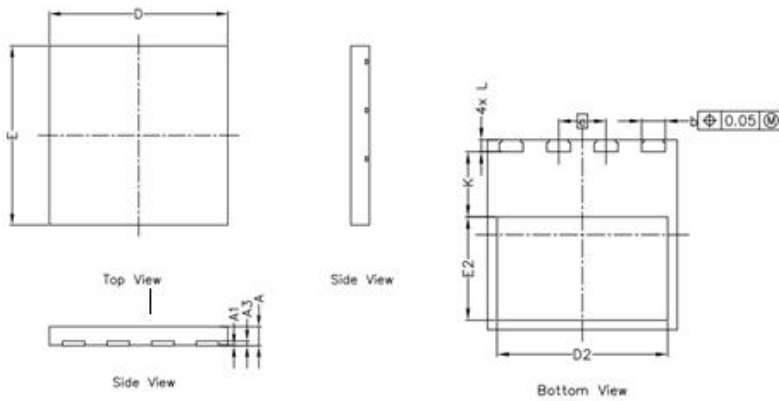
Fig.8-Current Derating
