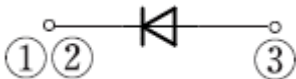

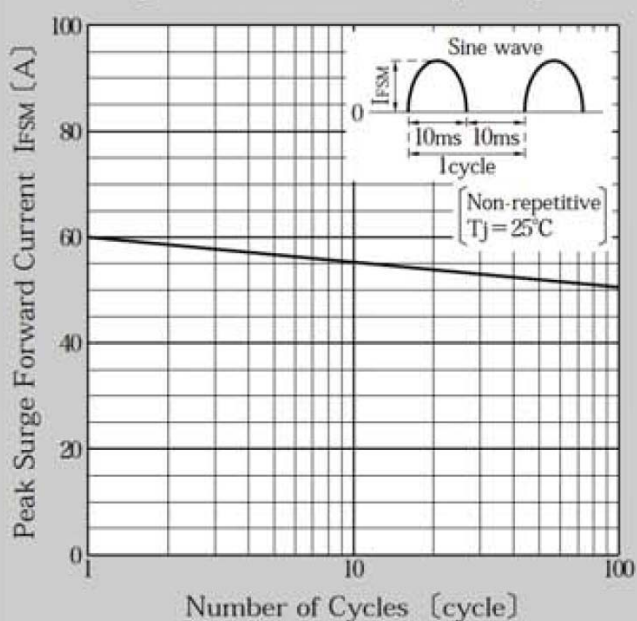
Forward Voltage



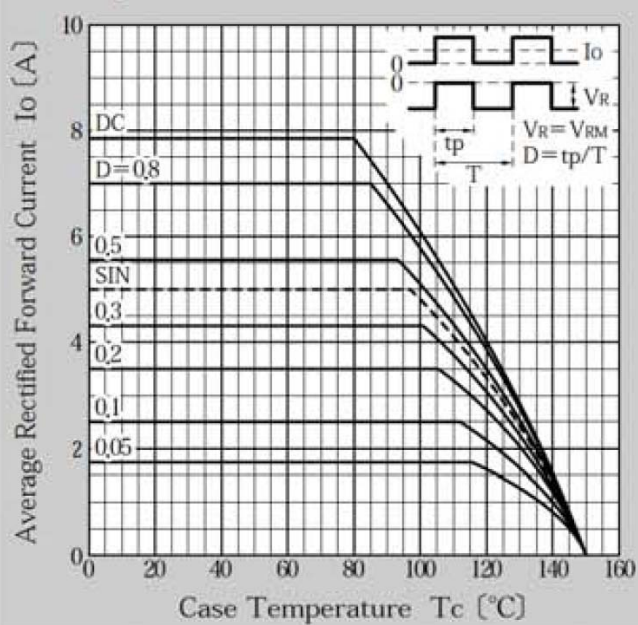
Forward Power Dissipation



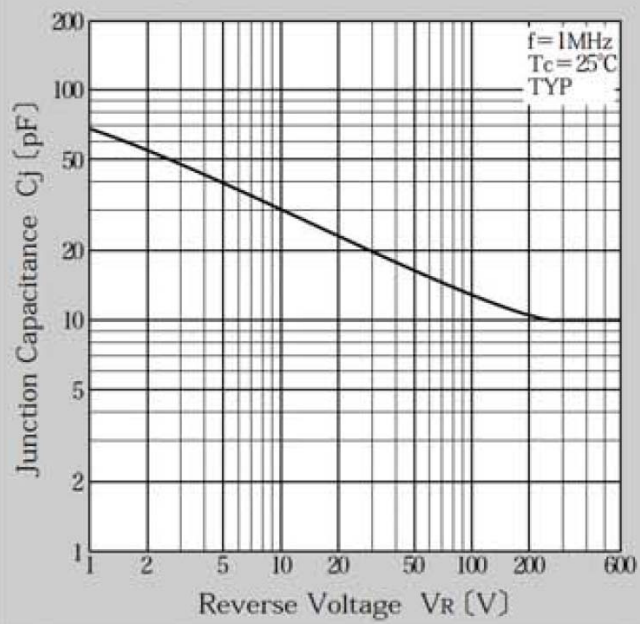
Peak Surge Forward Current Capability



Derating Curve T_c - I_o

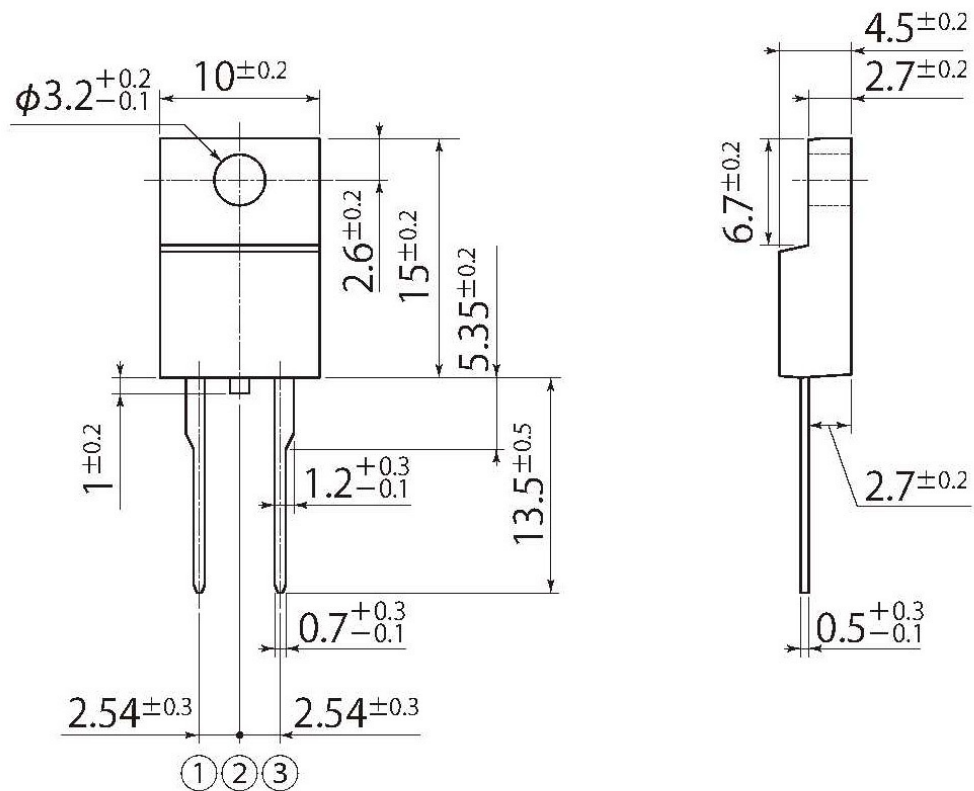


Junction Capacitance
