








Max. Permissible Forward Current

Permissible Pulse Handling Capability




Permissible Pulse Handling Capability





Glossary

- 1) **Radiant intensity:** Measured at a solid angle of Ω = 0.001 sr

Applying any continuous reverse bias or forward bias below the voltage range of light emission shall be avoided because it may cause migration which can change the electro-optical characteristics or damage the LED.
- 4) Wavelength: The wavelengths are measured with a tolerance of ±1 nm.
- 5) Forward Voltage: The forward voltages are measured with a tolerance of ±0.1 V.
- 6) Total radiant flux: Measured with integrating sphere.
- 7) Thermal resistance: junction - ambient, mounted on PC-board (FR4), padsize 16 mm² each
- 8) Typical Values: Due to the special conditions of the manufacturing processes of semiconductor devices, the typical data or calculated correlations of technical parameters can only reflect statistical figures.
