




Fig. 1 - Typical Output Characteristics, T<sub>C</sub> = 150 °C




Fig. 2 - Typical Output Characteristics, T<sub>C</sub> = 150 °C




Fig. 3 - Typical Transfer Characteristics




Fig. 4 - Normalized On-Resistance vs. Temperature




Fig. 5 - Typical Capacitance vs. Drain-to-Source Voltage




Fig. 6 - Typical Gate Charge vs. Gate-to-Source Voltage






Fig. 7 - Typical Source-Drain Diode Forward Voltage




Fig. 8 - Maximum Safe Operating Area




Fig. 9 - Maximum Drain Current vs. Case Temperature




Fig. 10 - Typical Drain-to-Source Voltage vs. Temperature




Fig. 11 - Normalized Thermal Transient Impedance, Junction-to-Case






Fig. 12 - Switching Time Test Circuit




Fig. 13 - Switching Time Waveforms




Fig. 14 - Unclamped Inductive Test Circuit




Fig. 15 - Unclamped Inductive Waveforms




Fig. 16 - Basic Gate Charge Waveform





Fig. 17 - Gate Charge Test Circuit



#### Peak Diode Recovery dV/dt Test Circuit








Fig. 18 - For N-Channel
