

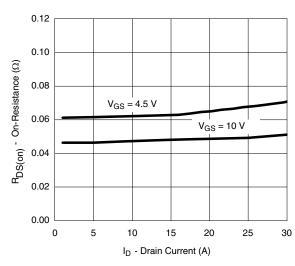



V_{GS} - Gate-to-Source Voltage (V) Transfer Characteristics




On-Resistance vs. Drain Current








On-Resistance vs. Junction Temperature




Source-Drain Diode Forward Voltage



Maximum Drain Current vs. Case Temperature





Normalized Thermal Transient Impedance, Junction-to-Ambient








Normalized Thermal Transient Impedance, Junction-to-Case




